



## Search for a WRNTY/SVC/SUBSCRIPTION — Asset Assoc — Criteria

## **Overview**

The Maintenance and Utilization module Warranty/Service/Subscription — Asset Association process provides the ability to update warranty, extended warranty, service, and subscription information supplied with an asset purchase.

Note

The options for CAGE CD are based on the contractors created in the Warranty/Service/Subscription Process. Choosing a CAGE CD further helps to eliminate the number of rows returned from the database when searching for a record.

### Procedures

#### Search for a WRNTY/SVC/SUBCRIPTION — Asset Assoc

One or more of the Search Criteria fields can be entered to isolate the results. By default, all

results are displayed. Selecting at any point of this procedure returns all fields to the default "All" setting. **Bold** numbered steps are required.

1. In the Search Criteria box, narrow the results by entering one of the following optional fields.

whereas selecting returns all fields to the default "All" setting. **Bold** numbered steps are required.


