#### **Release Notes Overview**

Release 2020.1.1 for the Defense Property Accountability System (DPAS) was released on March 27, 2020.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts eCatalog, Maintenance and Utilization, Materiel Management, Mobile Platform, Property Accountability and Warehouse modules.

The following feature, which is a part of Mobile Platform SCR 1235, was implemented by this release:

SCR #1235 - Mobile Application-Physical Inventory - Improved Bulk Inventory Support

- Provided the ability to complete bulk inventory counts with visibility to appropriate business key values.
- Provided the ability to view and multiple inventory details when scanned data does not uniquely identify the asset
- Provided better visibility/accessibility to view, capture and change container and subloc information
- Provided better support for large file inventories
- Provided better filtering and sort options within the user interface

# Warehouse Management (WM) Module

## **System Change Request (SCR)**

The following feature, which is a part of Warehouse Management SCR 1564, was implemented by this release:

SCR #1564 - Warehouse Receiving - Asset Receiving Updates for Large Quantities of Serial Assets

Added ability to receive for up to 10,000 serialized end items at a time through the use of a spreadsheet
upload in Warehouse. Upload is currently constrained to serialized end items only. It does not include kits
or bulk items, and is not for use against items sent from Warehouse Transfer.



The following feature, which is a part of Warehouse Management SCR 1501, was implemented by this release:

# SCR #1501 - Include the UIC description wherever the UIC is displayed or used within DPAS

• Added a "UIC description" to the Individual Issue/Return Inquiry and Member Activity Inquiry screens.

The following feature, which is a part of Warehouse Management SCR 1575, was implemented by this release:

## SCR #1575 - Inventory Activity added to Stakeholder role

• Provided read-only access to the inventory Activity queries by anyone using the Stakeholder Role in warehouse.
