Release Notes Overview

Release 2021.2.1 for the Defense Property Accountability System (DPAS) was released on June 11, 2021.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts Appointment Scheduler, eCatalog, Inventory, Mobile Platform, Maintenance and Utilization, Property Accountability and Warehouse Management modules.

Appointment Scheduler

System Change Request (SCR)

The following feature, which is a part of Appointment Scheduler SCR 01622, was implemented by this release:

SCR #01622 – Check-In Kiosk / Member Cleanup

- Provides enhanced data management for the appointment members and contact information. Once the member has fulfilled their scheduled appointment, there is no requirement to maintain the information within the appointment databases. Member data will be cleaned up to the minimum information required for historical metrics and reporting. This will ensure that with each appointment, the member information is refreshed to include any changes made since their last visit.

eCatalog

System Change Request (SCR)

The following feature, which is a part of eCatalog SCR 01659, was implemented by this release:

SCR #01659 – Agency Catalog Interfaces / Cleanup and Resolve Invalid Lookup Values in the External Catalog

- Addresses the invalid foreign key values that reside in the external agency catalog. This ensures these values do not cause issues with the background processes, or get pulled into DPAS, thereby causing issues with the cataloging processes.

Mobile Platform

System Change Request (SCR)

The following feature, which is a part of Mobile Platform SCR 01637, was implemented by this release:

SCR #01637 – Reconstitute Planned Pick for HHT

- Provides the capability to view, pick and deliver Planned Picks via an AIT Terminal that is compatible with DPAS.
- The solution downloads Planned Picks for disconnected operation, and uploads them when the terminal is reconnected.
- All business processes related to confirming the Pick are complete; such as updating the MRO to Picked/Ready for Release, and generating a QC action when applicable.
- When using Planned Picks while connected, the process receives new picks and posts completed picks in real-time.

Maintenance and Utilization (M&U) Module

- Type Asset Cd column has been added to the Physical Inventory Reconciliation Results Inquiry.

The following feature, which is a part of Warehouse Management SCR 01643, was implemented by this release:

SCR #01643 – Generate DLMS867I for Materiel Release Order

- Adds the ability to setup an externally managed Owning DoDAAC to outbound an 856S with MRO shipments.

 - Odd changes to the number of pages.

DLMS Transaction Review (WH) (LPWHN77)

- Corrected a deficiency where expanding the detail grid in DLMS inquiry was causing a critical error.
