Release Notes Overview

Release 2021.2.2 for the Defense Property Accountability System (DPAS) was released on July 2, 2021.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts eCatalog, Maintenance and Utilization, Materiel Management, Property Accountability, and Warehouse Management modules.

eCatalog Module

Help Tickets

The following eCatalog Help Tickets were closed by this release:

- Corrected a deficiency where a period (.) could not be utilized in a Stock Number.

AESIP Catalog Data Validation and Staging (LPCTI28)

- Corrected a deficiency where the AESIP Catalog Data Validation and Staging / Update of interfaced Manufacturer Part Number information would not update correctly.

Maintenance and Utilization (M&U) Module

System Change Request (SCR)

The following feature, which is a part of Maintenance and Utilization SCR 01532, was implemented by this release:

SCR #01532 - Additional User Functionality to Schedule Preventive Maintenance

- Additional User Functionality to Schedule Preventive Maintenance is adding two things to the functionality:
 - Tier selector on the header of the new pages.
 - Adding the Work Plan field to the Maintenance Schedule search criteria.

SCR #01706 – ICP Catalog Roles

- DPAS added a new role to the ICP that allows users to access the Catalog Management related screens. These screens will permit access for catalogers while logged into the ICP.
