### **Release Notes Overview**

Release 2021.4.3 for the Defense Property Accountability System (DPAS) was released on February 18, 2022.

This release includes System Change Requests and corrects program deficiencies identified by the user community. The update impacts Maintenance and Utilization, Property Accountability, and Warehouse Management modules.

# Maintenance and Utilization (MU) Module

### **System Change Request (SCR)**

The following feature, which is a part of Maintenance and Utilization SCR 01739, was implemented by this release:

#### SCR #01739 - Create M&U Role for Custodian-RO-RI

Created a Role named M&U Custodian. With this role the user will be able to create and close out a WO,
Update the WO, Create Warranties and create preventive maintenance schedules. However, this role is
limited in the WO process as users will not have the ability to update the following Sub WO Tabs: Tasks,
Parts, Tool/Equipment, and Certs.
