# **Release Notes Overview**

Release 2022.1 for the Defense Property Accountability System (DPAS) was released on April 8, 2022.

This release includes System Change Requests and corrects program deficiencies identified by the user community. The update impacts, Appointment Scheduler, Catalog, Enterprise, Inventory Control Point, Maintenance and Utilization, Property Accountability, and Warehouse Management modules.

# System Change Request (SCR)

The following feature, which is a part of Catalog SCR 01758, was implemented by this release:

### SCR #01758 – Implement Tech Refresh for Manufacturer Part Nbr Catalog Program

 Manufacturer Part Number Search/Add/Update/Delete screens for the DPAS catalog have been modernized to meet DPAS tech refresh standards utilizing micro services. Front end changes include use of drawers for add and update, and other applicable DPAS design standards for grid functionality.

The following feature, which is a part of Catalog SCR 01633, was implemented by this release:

# SCR #01633 - Modernize the LIN/TAMCN catalog program

 LIN/TAMCN Add/Update/Delete screens for the DPAS catalog have been upgraded to DPAS tech refresh standards utilizing micro services. Front end changes include use of drawers for add and update, and other applicable DPAS design standards for grid functionality.

The following feature, which is a part of Catalog SCR 01758, was implemented by this release:

### SCR #01758 - Add Mfr Part Nbr fields to Stock Number AUD when Stock Item Cd is 'B' Part Number

• When a Stock Number is a Stock Item Type = 'B - Part Nbr', it is now required to have one and only one manufacturer record associated to it. This requirement is in all catalogs across all modules. To meet this



requirement, Manufacturer fields have been added to the Stock Number add screen so that the Manufacturer Name, Manufacturer Part Number, CAGE Cd, and Manufacturer Model Number can be associated with the Stock Number when it is being added to DPAS. During the add process, the CAGE + Part Number will be used to auto-generate a Stock Number when locally cataloged, or the user has the option of changing the auto-generated Stock Number to meet a specific business need. Stock Numbers from external sources will remain the same. The 1-to-1 Stock Number to Manufacturer association is also enforced on the Manufacturer Add/Update/Delete process when Stock Item is Type B.

#### SCR # 01735 - Physical Inventory / Mobile Authentication

- Added ability for DPAS user to execute inventories, pulling available inventories to handheld device for execution and upload results to DPAS server.
- Added ability for non DPAS user to execute inventories in offline and online environments (with and without imported information).

# Warehouse Management (WM) Module

#### System Change Request (SCR)

The following feature, which is a part of Warehouse Management SCR 00786, was implemented by this release:

SCR # 00786 - EAS action items / exclude members with 0 (zero) outstanding qty

• EAS Alert will only notify the system user of members who have equipment and their EAS is near expiring, vice simply showing that a member's EAS is expiring. EAS expiration is only a problem if that member has an outstanding qty of equipment.

The following feature, which is a part of Warehouse Management SCR 00941, was implemented by this release:

SCR # 00941 - DD form 1348 / Serial Number sort order (alphanumerical)

• DD 1348 form now lists Serial Numbers in alphanumerical order.

The following feature, which is a part of Warehouse Management SCR 01648 was implemented by this release:

SCR # 01648 - Individual Issue / support pRFID asset selection

- Ability to capture pRFID tags within individual issue
- Use captured tag information to identify selected materiel
- Populate the individual issue grid for review prior to signing
- Provide visibility to unknown tag reads and a method to remove from the issue

The following feature, which is a part of Warehouse Management SCR 01511 was implemented by this release:

SCR # 01511 - Unit Return / "Return all" outstanding inventory (phase 2)

- Add checkbox to search criteria to filter search by inventory accountable to session warehouse only
- Default to 'true'
- Remove 'Stock Nbr Rollup' from Unit Return grid header actions



The following feature, which is a part of Warehouse Management SCR 01510 was implemented by this release:

# SCR # 01510 - Unit Return / Column Ordering and Sort

- When the user first clicks a column, it should sort in ascending order and then the second click on the same column sorts in descending order.
- First column selected is the primary sort and the second column selected is the secondary sort.

The following feature, which is a part of Warehouse Management SCR 01673 was implemented by this release:

## SCR # 01673 - Appt Scheduler / Optional walk-in appointments

- Provide the ability to configure appointment types as 'no appt required' at the service center level.
- Provide the ability to optionally create walk-in appointments within the application, when configured.

The following feature, which is a part of Warehouse Management SCR 01674 was implemented by this release:

## SCR # 01674 - Appt Scheduler / Reoccurring scheduling options

- Provide the ability to add appointment type with or without recurrence pattern.
- Provide the ability to edit recurrence pattern for appointment type.

The following feature, which is a part of Warehouse Management SCR 01672 was implemented by this release:

### SCR # 01672 - End of Active Service Outstanding Items Inquiry

 Inquiry allows the user to view outstanding inventory on a members account. The user can print out one or multiple DW 05I and DW 05T forms. The user can select a member and send an email reminder to a specific member about their outstanding inventory. There is a background job that runs every 24 hours to send the appropriate members an email reminding them of their outstanding inventory.

### SCR # 01672 - Reservist End of Contract

• Provided the functionality to prevent reservist(s) from showing on the End of Active Service Outstanding Items inquiry as well as the End of Active Service open actions.

The following feature, which is a part of Warehouse Management SCR 01675 was implemented by this release:

### SCR # 01675 - Member Profile / Implement Attachment Microservice

• User can upload attachments in Member Profile.

The following feature, which is a part of Warehouse Management SCR 01678 was implemented by this release:

### SCR # 01678 - Inventory Over Under Site change report

• Inventory Over Under Report can be ran in a summary mode which shows only overages / underages and lists all data in one sheet.

The following feature, which is a part of Warehouse Management SCR 01652 was implemented by this release:



# SCR # 01652 - Unit/Individual Reconciliation (Inventory Issued Assets)

• Created new process: LPWHN95 - Issued Inventory AUD. This will the user to update the Date of Last Inventory for issued items.

The following feature, which is a part of Warehouse Management SCR 01435 was implemented by this release:

# SCR # 01435 - Inventory Activity Reason Code

• Inventory Activity Inquiry search criteria allows selection of multiple reason codes when performing a search. The following feature, which is a part of Warehouse Management SCR 01277 was implemented by this release.

## SCR # 01277 - Disposition / Process Improvements

• The user now has the ability to view item history once an asset is disposed. Once a serialized item is disposed, the asset remains in an archived status. The user has the ability to bring disposed assets back to life.

The following feature, which is a part of Warehouse Management SCR #01135 was implemented by this release.

## SCR # 01135 - Disposition / provide the ability to select and print multiple DD form 1348(s)

• The user now has the ability to select and print multiple DD 1348's. This feature will go out to the customer in 2022.2 in the updated Disposition process.

The following feature, which is a part of Warehouse Management SCR #0168 was implemented by this release.

## SCR # 01068 - Disposition / Provide the ability to select and print multiple DD form 1149(s)

• The user now has the ability to select and print multiple DD 1149's. The feature will go out to the customer in 2022.2 in the updated Disposition process.
