Release Notes Overview

Release 6.3.40 for the Defense Property Accountability System (DPAS) was released on March 15, 2019.

This release includes system change requests and corrects program deficiencies identified by the user community. The updates impact Administration, Materiel Management, Maintenance and Utilization, Property Accountability, and Warehouse Management Modules.

Administration Module
