Release Notes Overview

Release 7.1.00 for the Defense Property Accountability System (DPAS) was released on July 26, 2019.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts Appointment Scheduler, eCatalog, Force Systems Management, Maintenance and Utilization, Materiel Management, Mobile Platform, Property Accountability, Registry and Warehouse modules.

Appointment Scheduler

- Users can create a template for each customer (by DoDAAC) that will automatically populate the details of a push Requisition from the ICP when applied.

System Change Request (SCR)

The following Mobile Platform SCRs were closed by this release:



SCR #1235 - Mobile Application

- Provided the ability to export physical inventory counts into a formatted excel file from Property
 Accountability and Warehouse modules. This feature is intended to enable the system to transmit expected
 inventory records from the Web application to any enabling system with the ability to apply counts or for
 manual entry. A follow on feature will be required in order to process these counts back to DPAS server and
 update inventory.
- Added the ability to identify business key values at the time of resolving Mobile inventory counts from the UWP application. Values such as Owning DoDAAC, Cond Cd, Project Cd etc need to be specified when more than one ICN is returned for a counted item.
- Enhanced UWP application with the following:
 - Addressed latency issue when parsing barcode
 - o Reformatted barcode scan block to be more user intuitive
 - Added additional details aide in asset identification
 - o Added control to force application offline
 - Provided ability to Purge the local database
 - o Provided ability to adjust Queue size

• Within Member Profile, users will be able add a Class Name to a Member's record. Class Name will also be available to Import through the spreadsheet template.

SCR #1326 - AFERMS Appointment Scheduler Requests - Generic Appointment Types

AFERMS users will be able to schedule 'generic' appointments through the Appointment Scheduler. These
'generic' appointments will not link to a DPAS process. The Appointment AUD has also been updated with
multi check in/check out and a Complete button to help facilitate these 'generic' appointments.

SCR #1349 - Physical Inventory tethered scan ability

 Provided the ability to conduct a physical inventory from the DPAS web application, using a tethered scanner device.

SCR #1379 - Turn line item red when other than A coded

Provided the ability to easily identify a SKO component that is less than condition code A.

SCR #1198 - Serviceable Storage

• Provided the ability to assign schedules to inspections and notify as due based on the location of materiel



SCR #1112 - Inspection Due Labels

Provide the ability to print inspection due labels.

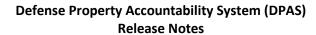
