* Web Release 2.2.00 July 20, 2012	*
* Release Notes	*

Web Release 2.2.00 for the Defense Property Accountability System (DPAS) effort was released on 20 July 2012. There is no action required by the user to receive the update.

System Change Request (SCR) in this release:

The following capabilities are provided with this SCR:

Wide Area Work Flow (WAWF) - This SCR is to provide for WAWF schema modifications.

- WAWF Inbound XML Import WPHRN20 WAWF released an updated XML schema that requires all systems that utilize the XML format to modify their programs that interpret the data for processing. The new WAWF schema version is 5.3. DPAS has revised its processing to accommodate the new schema.
- WAWF Export WPHRI02 WAWF released their new 5.3 version of their XML format that requires all users of that schema to modify their processing to accommodate the new format. This change to DPAS allows DPAS to continue sending data to WAWF using the new format.

The following capabilities are provided with this SCR:

DPAS - 00327 - Conversion to Web DPAS - This SCR is to provide for the transition of business processes from GUI DPAS to Web DPAS. In this release, additional functionality was incorporated to support the Army's Line Item Number (LIN) Authorization processes.

- Authorization LIN/TAMCN Add/Update/Delete WPAUN05 New user process that provides the capability to add/update/delete authorizations. Process permits the user to authorize by UIC / LIN_TAMCN / Paragraph Number (optional).
- Paragraph Number Add/Update/Delete WPAUN16 New user process that provides the capability to add/update/delete Paragraph Numbers for use with the new Authorization LIN_TAMCN process. Paragraph Numbers will also be able to be associated with a Property Custodian via the Custodian Process.
- Stock Number/Selected Mass Update WPCTN02 Process was modified to assign the same Authorization Key to all records with the same Bulk Business Key when Authorization is equal to "L-LIN".

- LIN/TAMCN Add/Update/Delete WPCTN11 Process was modified to support Authorization and SB700-20 processes. When LIN/TAMCN is currently associated with an active Stock Number or Authorization row, the delete/inactivation of the LIN_TAMCN is not allowed. When LIN/TACMN is associated with record supplied by the SB700-20 Interface, do not allow user to change the LIN/TAMCN data.
- Close Inventory WPHRN03 Configured to test the Bulk Common Function for Authorization changes.
- Update Inventory Data WPHRN05 Configured to test the Bulk Common Function for Authorization changes.
- Asset Receiving / Asset Receiving Background State WPHRN11 / WPSAB13 Asset Receiving was modified to support the identification of the LIN/TAMCN Authorization that provides for the UIC to have the asset in their custody. To accommodate for the selection of the LIN/TAMCN, an Authorization Browse was incorporated into the Property Custodian Selection when the UIC has been identified as managing assets to authorizations using the LIN/TAMCN methodology. In addition to modifications for the LIN/TAMCN assignment, the DoD Serial Number was relocated to the Asset Tab to enable the receipt of like assets within the same process that have already been assigned their DoD Serial Number.
- Asset Disposition Background State WPSAB29 Marked Authorizations as deleted for disposed asset and removed call to UIT Common Function.
- Custodian Add/Update/Delete WPHRN42 A new tab was added to the process to allow the association of Paragraph Numbers that the Custodian is responsible for relative to the LIN/TAMCN and Paragraph Number Authorization processes.
- Asset Update / Asset Update Background State WPHRN51 / WPSAB17 The process was modified to support the LIN/TAMCN Authorization processes. Changes include a new LIN/TAMCN Browse and changes in the Cost Center.
- Asset Transfer / Asset Transfer Background State WPHRN52 / WPSAB15 The process was modified to support the LIN/TAMCN Authorization processes.
- Asset Reversal Background State WPSAB21 The process was modified to restore the associated LIN/TAMCN Authorization and / or UIC Paragraph Number as part of the asset restoration, when either of them had been previously deleted. This is required to maintain data integrity within the system.
- ACTBL UIC/UIC Add/Update/Delete WPUTN03 Modified the process so that the Authorization Drop Down values reflect the Authorization Type the UIC is eligible to select.
- Authorization LIN/History Inquiry WPAUQ04 New LIN/TAMCN
 Authorization History Inquiry process was added to provide the user
 with the capability to view the history of their changes to their
 LIN/TAMCN Authorizations.

- TDA Paragraph Nbr Inquiry (Include History Tab) WPAUQ05 New TDA Paragraph Number Inquiry (Include History Tab) process was added to provide the user with the capability to view the current and history of their TDA Paragraph Numbers.
- Authorization Inquiry WPAUQ08 New LIN/TAMCN Authorization Inquiry process was added to provide the user the capability to view their current Authorizations.
- Custodian Inquiry WPHRQ13 Changed process to enable the viewing of the TDA Paragraph Numbers that have been associated with the Custodian.
- Asset Inquiry WPHRQ14 Added new data fields to support Maintenance and Utilization and SB-700-20. Added "Generic" Cost Center to search criteria with Owning, Funding and Depreciation as selectable fields on the Field Configuration Page. It now displays Cost Centers on inquiry.
- Asset Activity Inquiry WPHRQ20 Added Paragraph Number, Description, Authorization LIN TAMCN, Catalog LIN/TAMCN and Owning Cost Center to field selection/data extract. Changed "COST CENTER" to "FNDNG COST CENTER". It now provides the history of AUTN Change before and after to history detail screen.
- UIC Inquiry WPUTQ01 Modified the inquiry to enable the user to view their LIN/TAMCN Authorization setting.
- LIN/TAMCN Browse WCGLM47 The LIN/TAMCN Browse was modified to support its use with LIN/TAMCN Authorizations.
- Authorization Browse WCGLM52 Modified Authorization Browse to browse.
- TDA Paragraph Number Browse WCGLM59 New TDA Paragraph Number Browse was updated to provide valid TDA Paragraph data retrieved from Master Table according to browse standards.
- Asset Detail Viewer WCGLX19 Modified the viewer changing "Cost Center" to "Fndng Cost Center" and added the display of Owning Cost Center, LIN/TAMCN and Authorization Record information.

The following capabilities are provided with this SCR:

DPAS - 00327 Conversion to Web DPAS - This SCR is to provide for the transition of business processes from GUI DPAS to Web DPAS. In this release, additional functionality was incorporated into the current UIT Interface to support the Army's Continuing Balance System - Expanded (CBSX) Reporting. The UIT Reporting process was also modified to become a background process rather than being a called process by all processes that affected UIT Reporting.

• UIT Business Logic Common Function - WCGLX15 - Changed the program to incorporate reporting of the LIN with the asset.

- UIT Interface Trigger WCHRG54 Added this new trigger to support the background reporting of UIT.
- UIT Interface Transaction Report WPHRR18 Modified the report to include the LIN/TAMCN value.
- UIT Asset Daily Scan Background WPSAB59 Added this new process to enable UIT reporting as a Background process.
- UIT Compare Batch WPSAB60 Added this new process to enable UIT reporting as a Background process.
- UIT Extract WPUTG02 Added this new process to enable UIT reporting as a Background process.

The following capabilities are provided with this SCR:

DPAS - 00327 Conversion to Web DPAS - This SCR is to provide for the transition of business processes from GUI DPAS to Web DPAS. In this release, DPAS is adding a new accounting interface with Logistics Modernization Program (LMP) to support the financial reporting of Asset Activity for the Army's Working Capital Fund Activies.

- Depreciation Update WPACN10 Modified the process to call the Accounting Common Function when the "Expense Code" is changed to allow for the generation of LMP Accounting Events.
- Appropriation Data Add/Update/Delete WPUTN04 Modified the process to call the Accounting Common Function on changes of Servicing Activity Code when Interface System Code is LMP (AK).
- LMP Accounting Interface Export WPACI18 New process added to provide for the creation of LMP Accounting Interface files.
- Accounting Interface Report WPACR12 Report was modified to add a new version for the LMP Accounting Interface.
- Accounting Control Common Function WCGLX09 Modified to support the unique reporting LMP requirements.
- Accounting Edits Common Function WCGLX12 Modified to add the field level edits specified by LMP Accounting Interface.
- GEX Interface Channels WPGLI01 Established new channel connections with GEX in support of the LMP Accounting Interface.

The following capabilities are provided with this SCR:

DPAS - 00327 Conversion to Web DPAS - This SCR is to provide for the transition of business processes from GUI DPAS to Web DPAS. In this release, modifications to the Maintenance and Utilization application were accomplished to provide the users of this application with Equipment Pool processes to support Dispatch Management.

- Work Order Add/Update/Delete WPMAN12 Modified the Work Order process to set the Unavailable Code to "Available" upon completion of the Work Order that was created as part of the Dispatch Return process.
- Maintenance Actions Add/Update/Delete WPMAN15 Added the display of open Dispatch Actions within the My Actions Dashboard. The Dispatch Actions will be viewable in calendar view and in grid view with the Calendar view being the default view.
- Maintenance Asset Utilization Add/Update/Delete WPMAN24 Modified the Utilization Process to prevent the user from updating a Utilization record that was recorded through the Dispatch process to ensure integrity of the Dispatch information. To update the user will need to update the row via the Dispatch Process.
- Dispatch / Dispatch Number Browse WPMAN30 / WCMAM09 New process added to enable the selection of Dispatch records via the Dispatch Id Browse.
- Asset Utilization Add/Update/Delete WPUTN30 Modified the Utilization Process to prevent the user from updating a Utilization record that was recorded through the Dispatch Process to ensure integrity of the Dispatch information. To update the user will need to update the row via the Dispatch process.
- Maintenance Activity Inquiry WPMAQ17 New inquiry added to display data from the Maintenance Activity table as an Enterprise level report.
- Dispatch Inquiry WPMAQ26 New inquiry added to enable the user to view dispatch activity.
- Equipment Utilization Form Request / Equipment Utilization Form WPMAR09 / WPMAR10 Modified the request to enable the printing by Dispatch Id and added Dispatch fields to the report.
- Equipment Pool Asset Report Request / Equipment Pool Asset Report WPMAR17 / WPMAR18 New report request and report added to enable the user to view assets assigned to Equipment Pools.
- MyAction Feeded Common Function WCGLX47 Modified to support the Dispatch records.
- Dispatch Number Generator Common Function WCGLX54 New function added that will generate Dispatch Numbers for the Dispatch Process. Numbers will be uniquely assigned by Equipment Pool using the Date and a Serial Number that is reset to 0001 each day.

- Real Time Report Generator Dispatch WCGLX56 New process added that enables a Dispatch form to be requested/printed from within the Dispatch process.
- Asset Identification Browse WCMAM04 Modifications were made to the Asset Id Browse to support its use within the Dispatch Process.

DPAS - 00327 Conversion to Web DPAS - This SCR is to provide for the transition of business processes from GUI DPAS to Web DPAS. In this release, modifications were made to a number of inquiries to provide better visibility among the Owning Cost Center, Funding Cost Center and Depreciation Cost Center fields/values and the re-esblishment of the RPUID requirement for all Real Property has been accomplished.

- Real Property Add/Update/Delete WPACN11 Modified this process to reinstate the edit for the Real Property RPUID field. In the initial release of Real Property accounting in DPAS, DPAS required the selection of a vaild RPUID for all Real Property. This requirment was subsequently suspended due to the Real Property Systems not having RPUIDs assigned to all of their Real Property Assets. The Real Property Managers have since reported that they have assigned and reported their RPUIDs to all of the Real Property they are managing; therefore, DPAS must reinstate the RPUID requirement for all Real Property Assets recorded in DPAS in order to remain in good standing with the Investment Review Board (IRB). DPAS has incorporated the capability to override this requirement for those users that may have extenuating circumstances where their assets are not being reported to the RPUID Registry. For those users that may have this condition, a request can be submitted to the DPAS Program Manager for relief in associating an RPUID with their Real Property Assets.
- Maintenance Management Assignment Add/Update/Delete WPUTN32 -Modified for this release.
- Depreciation Inquiry WPACQ01 Added the Owning Cost Center Fields to the inquiry and changed current "Cost Center" labels to "Fnding Cost Center".
- CIP Inquiry WPACQ03 Added the Owning Cost Center field to the inquiry.
- Accounting Transactions Inquiry WPACQ04 Updated current Cost Center to Fnding Cost Center.
- Real Property Inquiry WPACQ06 Added the Owning Cost Center.
- Capital Asset Inquiry WPACQ10 Added the Owning Cost Center field to the inquiry. Changed "Cost Center" to "Fnding Cost Center".
- Personal Property Improvement Inquiry WPACQ12 Added the Owning Cost Center field to the inquiry.
- Real Property Improvement Inquiry WPACQ13 Added the Owning Cost Center field to the inquiry.

- Real Property Capital Asset Inquiry WPACQ14 Added the Owning Cost Center field to the inquiry.
- Maintenance Asset Inquiry WPMAQ10 Added the Owning Cost Center field to the inquiry. Change all instances of "Cost Center" to "Fnding Cost Center".
- Asset Inventory Inquiry WPHRQ16 Added the Owning Cost Center field to the inquiry.
- Inventory Detail Inquiry WPHRQ34 Added the Owning Cost Center field to the inquiry.

This release contains the following Program Trouble Reports (PTRs):

Asset Management

Asset Import Update - WPHRI07 - If a Location is invalid, the process was stopping i.e. did not continue processing other rows. The process was modified to send invalid Location error message to the Error File and to continue onto the next record until all records are processed. Modifications were made to conform to Batch standard as requested. PTR 9952 applies.

Excess Asset - WPHRN39 - User Preferences are not being pre-populated in process: DSPSL Activity, DODAAC, Point of Contact (POC), Location (LOC) and Sub Location (SUB LOC). Changed logic to retrieve user preferences using the My DPAS user preferences. Remedy Ticket 97472 applies. PTR 9794 / Bug 444 applies.

Asset Update - WPHRN51 - Corrected the process for when the user received an invalid warning message that indicated several assets' Capital Code changed although the location was changed and the Capital Code was not changed. Remedy Ticket 99854 applies. Bug 846 applies.

Catalog

Stock Number Add/Update/Delete - WPCTN01 - Modified the process in how it handled the Utility Measure Code and Utility Service Life for assets that have been identified as subject to Maintenance / Utilization. The fields will now be disabled when Asset exists on the Maintenance Asset Master Table to ensure data integrity. PTR 9836 applies.

Stock Number/Selected Mass Update / Stock Number Mass Update Batch - WPCTN02 / WPSAB18 - Modified the process in how it handled the Utility Measure Code and Utility Service Life for assets that have been identified as subject to Maintenance / Utilization. The fields will now be disabled when Asset exists on the Maintenance Asset Master Table to ensure data integrity. PTRs 9837 and 9838 apply.

Inventory

Update Inventory Data / Bulk Asset Common Function - WPHRN05 / WCGLX06 - Configured to test the Bulk Common Function for Authorization changes to resolve server error that was received. For the Authorization changes when creating a new Bulk record, the common function needs to update the Asset Master Table with Authorization Key. Remedy Ticket 99364 applies. PTRs 9940 and 9957 apply / Bug 797 applies.

Maintenance and Utilization

Monthly Utilization Report Request - WPMAR07 - Equipment Pool Drop Down is not displaying the Equipment Pools correctly when dealing with different update level filtering per FRD. PTR 9979 / Bug 696 applies.

Security

Security Login Validation - WPSEN01 - The process was modified so that the Site Level Message of the Day would display as required. Remedy Ticket 99560 applies. Bug 787 applies.

Supply Room

Supplier Add/Update/Delete - WPSRN08 - The history remarks on a display only page are available for entry - the entered information cannot be saved, but the field is open for text entry. Process was corrected to not allow data entry on display only page. Remedy Ticket 99793 applies. Bugs 715 and 838 apply.

Supply Room Inquiry - WPSRQ02 - Added Enterprise level access to all stores for Enterprise Users where inquiry access level in the User Supply Room record is "6" (Enterprise Level), the inquiry access is not being applied properly. The Inquiry dropdowns are only showing values applicable to the Supply Room the User is assigned to, not all Supply Rooms in the Enterprise. Remedy Ticket 98066 applies. PTR 9802 applies.

Miscellaneous

DPAS ABUDL Framework - WCGLM23

- 1) Ensure session variables specific to a user thread can be unique, reliable and cleared when context requires their removal. PTR 9806 applies.
- 2) Corrected as requested changes needed to the Team Preferences, Fuel Type Information, Misc preferences and the Roles getting blanked out. PTR 9944 / Bug 631 applies.

Project/Task Browse - WCGLM56 - Task Code Browse is not functioning with wildcard "%" when searching on Project Number. Condition occurs when Task Code does not exist for Target Project and there is a single project in the interim result project level wildcard request. Wildcard request modified to force user to click incomplete Project Number in order to reveal to user that no Task Code is loaded for the Target Project Number and verified that Project Name functions the same. Remedy Ticket 96419 applies. PTR 9792 / Bug 441 applies.

Work Plan Id Browse - WCMAM02 - Modified browse criteria as requested to pull only from Maintenance Work Plan Type Look Up when schedule flag equals "1" if called by the Schedule Preventive Maintenance Add/Update/Delete process. PTR 9864 applies.

Event Log Viewer - WPSAN18 - The process was modified to prevent an error when using Datetime as parameter when value passed presumed is to be null. PTR 9966 applies.

DPAS Version Number File - WPSAN29 - Change Web Version Number on footer to 2.2.00 per specifications. PTR 9663 applies.
