Web Release 2.3.01 for the Defense Property Accountability System (DPAS) effort was released on 18 December 2012. There is no action required by the user to receive the update.

System Change Requests (SCRs) in this release:

The following capabilities are being provided with this SCR:

DPAS - 00454 - Inquiry Accounting Add DoD Serial Number - This SCR is to provide for the capability to capture the Line Item Receiving information for assets in the new DoD Serial Number field. The new field, "DoD Serial Nbr" will be added to the Capital Asset Inquiry Field Selection screen. This field is required for financial transactions and will be used by accountants who need to display this information in their Accounting Reports.

- **Personal Property Capital Asset Inquiry - WPACQ10** - Modified the process to display the DoD Serial Number field as part of the inquiry.

The following capabilities are being provided with this SCR:

DPAS - 00536 - UIC Custodian Select All Option - This SCR is to provide for improving efficiency, time management, accuracy and financial reporting for the DPAS Account Management Team. Currently, when a user requires access to all UICs or Custodians, each box must be individually selected. At times, this may be in excess of 150 clicks for one user. Adding a "Select All" and "Deselect All" command button to the screen will eliminate the requirement to select individually every UIC or Custodian for the Application Security Officer User Type Code when adding UICs or Custodians to a user's DPAS Account.

- **Actbl UIC/UIC/Custodian Nbr Access - WPSN25** - Allowing "Select All" functionality in User Custodian Security process.

The following capabilities are being provided with this SCR:

DPAS - 00537 Security Non Search Capability - This SCR provides the user with the capability to key in and validate user id when the value is known. It eliminates the multiple page refreshing that is currently occurring when selecting the browse option.

- **Actbl UIC/UIC/Custodian Nbr Access - WPSN25** - Added logic to validate user id textbox entry.

- **User Role Assignment Add/Delete - WPSEN04** - Modified the process to allow the security user to be able to enter directly a user id in addition to having the browse option in the User Role Assignment process.

The following capabilities are being provided with this SCR:

DPAS - 00540 Asset Transfer Agency Radio Button Option - This SCR provides the user with the capability to determine what radio button will be the default option on the Search Criteria page for Capital, Non-Capital, Accountable, Non-Accountable and/or both asset types for their particular Agency in the DPAS Asset Transfer Process. It can be done by using the User Preferences Process.

- **Asset Transfer - WPHRN52** - Modified the process so that the user can decide what they wanted defaulted on the Search Criteria page, 'Capital', 'Non-Capital' or 'Both'. They can do this by using the User Preferences Process.
- **User Preference Update - WPSEN06** - Modified the process to allow the user to preset the default for Asset Transfer Search Criteria to "Capital", "Non-Capital" or "Both".

This release contains the following Program Trouble Reports (PTRs) Bugs:

Accounting

Accounting Control Common Function - WCGLX09 - Corrected the process to stop erroneous accounting transactions being sent to our customers that required manual deletion on the customer's part. The Mass Stock Number Change process was added to this common function. It evaluates the Asset Code, Asset Category Code and Stock Number to determine if a change has been made to any of these three values when changing from one Stock Number to a new one. When a change is presented, the Accounting Transaction Receipt/Change Common Function (WCGLX07) is called to generate the proper accounting transactions. Remedy Ticket 99219 applies. Bug 4966 applies.

Compute Depreciation - WPACN13 - Added new statistical information and appended record counts to the Processing Remarks column. Bug 5297 applies.

Asset Management

Asset Inquiry - WPHRQ14 - Process modified to no longer display deleted UIIs for an asset on the Basic Tab. Remedy Ticket 102180 applies. Bug 4897 applies.

Asset Update - WPHRN51

- 1) Process modified to send Total Cost instead of Dollar Amount to allow proper conversion of ancillary data. Remedy Ticket 100894 applies. Bug 1613 applies.

Authorization

Authorization (LIN/TAMCN) Add/Update/Delete - WPAUN05 - Changed the process to allow the user to select different Authorization Property Type Codes. Removed the Property Type automatic populate and validate features if the Authorization Document Number begins with "CTA". Remedy Tickets 101552 and 102114 apply. Bug 5167 applies.

Maintenance and Utilization

Audit Viewer - WPMAN21 - Revised searched fields on the User Identify Search screen of the Work Order Audit Viewer. Bug 946 applies.

Address Add/Update/Delete - WPUTN13 - Corrected the process to filter out deleted records when checking for duplicates and allowing previously deleted addresses to be reactivated back into the system via the add process. Remedy Ticket 102299 applies. Bug 4922 applies.

Report Manager - WPUTR01 - Added the Serial Lot Number to the Item Description column to display. Remedy Tickets 102321, 102322, 102325 and 102697 apply. Bug 4985 applies.

UIT Daily Extract - WPUTG02 - Reversed the order of the Authorization Line Item Number (LIN) and Catalog LIN in the Extract File. The Authorization LIN and Catalog LIN in the Substitution File have been successfully reversed. Remedy Ticket 102520 applies. Bug 5057 applies.

UIT Recon Extract - WPUTG15 - Reversed the order of the Authorization LIN and Catalog LIN in the Extract File. The Authorization LIN and Catalog LIN in the Substitution File have been successfully reversed. Remedy Ticket 102520 applies. Bug 5058 applies.

Miscellaneous

DPAS Version Number File - WPSAN29 - Change Web Version Number on footer to 2.3.01 per specifications. Bug 4927 applies.

Vehicle Cost Accounting Agency Predefined Report - WCUSS38 - Added Site Id to display on the report. Bug 4944 applies.
