Web Release 2.3.02 for the Defense Property Accountability System (DPAS) effort was released on 04 March 2013. There is no action required by the user to receive the update.

The following SCR was implemented in Release 2.3.01 but was not included in the Release Letter.

DPAS - 00528 - Quarterly Security Reports - This SCR provides Account Management (Security) the functionality to run Security reports without the assistance from NAVSUP.

- **User Account History Inquiry - WPSEQ06** - Added a new inquiry for all DPAS users to show User Account History Status data including Application Security Officer privileged accounts.

System Change Requests (SCRs) in this release:

DPAS - 00327 - Modernization - Attribute Enhancement - This SCR provides Attributes functionality to users within the Web DPAS Application.

- **Stock Number Add/Update/Delete / Asset Template Browse - WPCTN01/WCGLM56** - Process changed to add a new Attribute(s) Template field and browse for user to associate an Attribute Template with a Stock Number. The user may search by Attribute(s) and Attribute Value(s) and display Attribute(s) and Attribute Value(s) on the search results grid. The Assigning Attribute Templates functionality was moved from the Asset Level to the Stock Number Level.
- **Stock Number / Selected Mass Update - WPCTN02** - Changed the process to display a Template/Attribute message for the user when changing the ACC of the Stock Number or changing from one Stock Number to another with different ACCs. The message will be, "Stock Nbr or ACC change may result in removal of Template(s) and Attribute Value(s)". Added a new Attribute(s) Template field and browse for the user to associate an Attribute Template with a Stock Number.
- **Stock Number/Selected Mass Update Background - WPSAB18** - Modified the process to display a message when the ACC for a Stock Number with asset(s) changes. The message states, "Template and Attribute Value(s) associated with Asset(s) will be deleted due to change of ACC".
- **Asset Update - WPHRN51** - Process modified to add Attribute functionality and remove the option to select/change the Attribute(s) Template. The Template will now be associated with the Stock Number when the Stock Number is created or updated in Mass Update.

- **Template Add/Update/Delete - WPHRN76** - Process modified to change the unique constraint from Template Name and ACC combination to only Template Name to eliminate confusion when creating new or maintaining existing Template records.
- **Attribute Value(s) Update - WPHRN77** - Modified the process to show the Attribute(s) Template as a non-editable text box, removed the "Delete" hyperlink and used the Stock Number instead of the ACC to determine if there is any associated template(s) for the asset to display.

DPAS - 00535 - FEDLOG Query Access - This SCR provides a new inquiry that allows the user to search the FEDLOG using mandatory criteria that is not currently available. The FEDLOG Inquiry will be added to the DPAS Inquiries under the Catalog submenu for user access. The benefits of integrating the FEDLOG into the DPAS Inquiry Menu would reduce time required to conduct research for Asset Disposal and Equipment Identification.

- **Fedlog Inquiry - WPCTQ08** - New process added to provide all users the capability to access FedLog information to assist in their day-to-day operations. This new inquiry will speed up research by allowing users to search by NIIN, Item Description or Federal Supply Class (FSC).

DPAS - 00538 - Catalog Clean Up - This SCR provides the user with the ability to identify stock numbers with no assets assigned within Web DPAS. These stock numbers may be selected for removal from the catalog when the Catalog Delete process is applied.

- **Catalog Records Available for Delete - WPCTN14** - Added a new process in the Catalog/Mass Updates Menu of DPAS to allow Catalog Role Users to remove unused Catalog records. The "Catalog Clean Up" or "Catalog Records Available for Delete" process would display all the Site's Catalog records not in use on a grid that can be saved to a file. A Delete button is available for the user to remove the unused Stock Numbers from the Catalog.
- **Catalog Clean-Up Report / Report Manager - WPCTR05 / WPUTR01** - A new report added to allow the DPAS Catalogers to review the deleted unused Stock Number records. This report will be automatically generated when the Catalog Clean-Up process has successfully deleted all unused Stock Number records for the Site's Catalog. This report is accessible through the Report Manager utility screens.

DPAS - 00539 - Catalog Stock Number Browse List Size Extension - This SCR permits the user to view more than the original 250 returned records.

- **Stock Number Browse - WCGLM12** - Modified the process to enable the user to search up to 250 records at a time. The browse shows multiple pages available when the number of returned Stock Numbers is greater than 250.

DPAS - 00543 - LIN Asset Custodian - This SCR provides the LIN Authorization (Army) user the ability to conduct Mass Transfers. It allows Army users to complete Mass Transfers when multiple LINs are selected. This will increase accuracy because LINs will not be overwritten by selecting a new LIN during the receipt of the transfer. It should only require a new LIN when Property Type Code equals "4" (TDA Authorization) during a Custodian to Custodian Transfer.

- **Asset Transfer - WPHRN52** - Modified the process for Custodian Transfers only to allow the user to transfer Assets with Authorizations to a new Custodian but allow the Authorization information on the record. This can be done with Authorizations when the Paragraph Number is not tied to a Custodian.

DPAS - 00553 Add Utilization Report in an EXCEL format - This SCR is to provide the user with the capability to produce the Utilization report in an EXCEL format as well as PDF to comply with the mandatory requirements which are not available currently. This is mission critical and imperative for the user's operations because of given directives from other organizations in regards to how information is formatted when reported up the chain.

- **Utilization Report / Reports Manager - WPMAR08 / WPUTR01** - Modified the process to enable the user to either request to print PDF or EXCEL file via request screen. The Report Manager screen will have a new Report ID entry to allow the user to distinguish the file type when retrieving the newly generated PDF or EXCEL file from the File System.

DPAS - 00554 - Add MyActions Metric Graphics Phase 1 - This SCR provides a new ability allowing users to view graphs to help make trending decisions. Users would be able to view Maintenance and Utilization Statistical Reporting graphs for the Work Order and Dispatch Dashboard Open Actions.

- **Maintenance Actions Add/Update/Delete - WPMAN15** - Modified the process to show statistical graphs.
- **MyAction Feeded Common Function - WCGLX47** - Modified the process to show statistical graphs.

DPAS - 00556 - Add Attribute Template Inquiry - This SCR provides for a new inquiry for users to view and determine what attributes and / or templates are available for an ACC. This includes the Template Names, Attributes, Field Types of each Attribute (i.e., drop-down, text box, etc.), maximum characters allowed, ACC the Template is associated to and when the field is mandatory. This is mission critical.

- **Attribute Inquiry - WPHRQ39** - New inquiry added to review, search and display the Attribute's name, description and available configuration types.

- **Template Inquiry - WPHRQ40** - New inquiry added to allow users to inquire information on the currently available Templates records as well as Attribute records available for each Template.

DPAS - 00557 - "Show Inquiry" control button on the Inquiry Search Criteria Page - This SCR provides the capability to bypass the Fields Selection page and go straight to the Inquiry Search Results Page. Using this button will display the information using the default selected Field from the Field Selection page.

- **Depreciation Inquiry - WPACQ01** - Modified the process by adding a Show Inquiry button on the Search Criteria page, so users can skip the Field Selection page and go straight to the Inquiry Search Results page.
- **CIP Inquiry - WPACQ03** - Modified the process by adding a Show Inquiry button on the Search Criteria page, so users can skip the Field Selection page and go straight to the Inquiry Search Results page.
- **Personal Property Capital Asset Inquiry - WPACQ10** - Modified the process by adding a Show Inquiry button on the Search Criteria page, so users can skip the Field Selection page and go straight to the Inquiry Search Results page.
- **Personal Property Improvement Inquiry - WPACQ12** - Modified the process by adding a Show Inquiry button on the Search Criteria page, so users can skip the Field Selection page and go straight to the Inquiry Search Results page.
- **Authorization Inquiry - WPAUQ01** - Modified the process by adding a Show Inquiry button on the Search Criteria page, so users can skip the Field Selection page and go straight to the inquiry Search Results page.
- **Stock Number Inquiry - WPCTQ01** - Modified the process by adding a Show Inquiry button on the Search Criteria page, so users can skip the Field Selection page and go straight to the Inquiry Search Results page.
- **Manufacturer / Asset Inquiry - WPCTQ06** - Modified the process by adding a Show Inquiry button on the Search Criteria page, so users can skip the Field Selection page and go straight to the Inquiry Search Results page.
- **LIN/TAMCN Inquiry - WPCTQ07** - Modified the process by adding a Show Inquiry button on the Search Criteria page, so users can skip the Field Selection page and go straight to the Inquiry Search Results page.
- **Asset Inquiry - WPHRQ14** - Modified the process by adding a Show Inquiry button on the Search Criteria page, so users can skip the Field Selection page and go straight to the Inquiry Search Results page.
- **UII Inquiry - WPHRQ24** - Modified the process by adding a Show Inquiry button on the Search Criteria page, so users can skip the Field Selection page and go straight to the Inquiry Search Results page.

- **Asset Utilization Inquiry - WPUTQ09** - Modified the process by adding a Show Inquiry button on the Search Criteria page, so users can skip the Field Selection page and go straight to the Inquiry Search Results page.

DPAS - 00559 - Add Additional Search Fields to Inquiry Drop-down List - This SCR inserts additional Search Criteria fields in the Asset Inquiry. The user clicks "Select an Item" to view the added search criteria selections: Reconciled Last Inventory Date, Non-Accountable, Asset Level Code, Asset Pilferable, HA Asset Id, Loan Code and UII Status Code. All selections include all available operands.

- **Asset Inquiry - WPHRQ14** - Modified the process to add additional Search Criteria fields to the drop down selection list as requested.

This release contains the following Program Trouble Reports (PTRs) Bugs:

Asset Management

Asset Update - WPHRN51

- 1) Process modified to display the Attribute instructions that are more applicable to the web page functionality and created a new page id for the page. Remedy Ticket 102314 applies. Bug 4920 applies.
- 2) Added new History Remarks Error Message. When over 256 characters are entered in the History Remarks field, error message 161 displays indicating the field contains invalid characters although that is not the issue. A new error message 982 was created to reflect the actual issue and replaced the previous on screen error message. Remedy Ticket 102962 applies. Bug 5457 applies.

Asset Transfer / Accounting Transactions Receipt/Change Common Function - WPHRN52 / WCGLX07 - Problem discovered in the Accounting Transactions Receipt/Change Common Function when generating Site to Site Transfer accounting transactions on the gaining side. Modified both processes to pass and update the correct Asset Code, Type Asset Code, Asset Category Code and Stock Number data accordingly for the Asset Master, Acquisition and Accounting Transactions Tables. Remedy Ticket 102323 applies. Bugs 5376 and 5377 apply.

Contract Inquiry - WPHRQ28 - Changed the "Cntr Name" label to "Cntrr Name" for process consistency. Remedy Ticket 102947 applies. Bug 5544 applies.

Assets On Loan Report - WPHRR24 - Modified the process to retrieve correctly all the proper assets to display missing address directory key data on the report. Remedy Ticket 103229 applies. Bug 5584 applies.

Accounting

Compute Depreciation - WPACN13 - The process was enhanced to check that a viable data base connection exists prior to creating a transaction. When a data base connection does not exist, the process attempts to create one. When an error is thrown that indicates processing of all Depreciation records has not occurred, it marks the DAC Job as incomplete/in error. Bug 5798 applies.

CIP Cost Add/Update/Delete - WPACN17 - Corrected the code which caused an unexpected error when more than 10 digits were entered in the Unit Cost field. Validation was added to allow only 13 characters to the left of the decimal on Cost. Remedy Ticket 102800 applies. Bugs 5547 and 5670 apply.

Auto Create Soft Improvements Batch - WPSAB46 - The application was logging errors as depreciation. The logging was changed to record errors as the proper application and put the correct title in the error log. Bug 5742 applies.

Authorization

Authorization (LIN/TAMCN) Add/Update/Delete - WPAUN05 - Changed the error message of "Invalid Entry - LIN/TAMCN" to "654 - LIN/TAMCN does not exist on Catalog LIN/TAMCN or is inactive for UIC" on the add page when the LIN entered is not found in the Catalog. Remedy Ticket 102973 applies. Bug 5512 applies.

LIN/TAMCN Authorization Inquiry - WPAUQ08 - Added the Authorization Document Number to Field Selection page. Remedy Ticket 102974 applies. Bug 5478 applies.

Catalog

Stock Number/Selected Mass Update - WPCTN02 - Modified the process to update ACC on all Assets. Remedy Ticket 103207 applies. Bug 5549 applies.

Manufacturer Add/Update/Delete - WPCTN03 - Modified the process to prevent deletion of an active manufacturer. Remedy Ticket 102463 applies. Bug 5140 applies.

Inventory

Update Inventory Data - WPHRN05 - Added specific error information to conform to logging standards. Bug 5644 applies.

Request Sensitive Inventory / Sensitive Inventory Report - WPHRN67 / WPHRR03 - Moved the Lot Number from the data extract onto the Inventory Line Item Table so that the report picks it up to display on the Sensitive Inventory Report. Remedy Tickets 102706 and 102986 apply. Bug 5552 applies.

Post Reconciliation Asset Master Inventory Update - WPHRN69 - Modification completed to streamline methods used to control multiple inventory reconciliation requests and to lessen risk of time out. Bug 5375 applies.

Maintenance and Utilization

Maintenance Activity Update - WPMAN03 - Changed the POC and Zip Code editable textbox fields to prevent user entry and populated the Zip Code field via the Address Browse. Remedy Ticket 102673 applies. Bug 5174 applies.

Schedule Preventive Maintenance Add/Update/Delete - WPMAN11 - Modified the prior existing error message 342 that stated "Enter year > 1699" to state "Enter year > 1752" so that a user cannot key in a Last Maintenance Date input of less than the year 1752. Bug 5667 applies.

Work Order Add/Update/Delete - WPMAN12

- 1) Corrected the issue where the View Button on Dispatch screens is causing a system error. Remedy Ticket 102665 applies. Bug 5557 applies.
- 2) Corrected the issue to perform only the total utilization quantity computation and validation check on currently metered assets so conversion from miles to days no longer occurs. Remedy Ticket 103608 applies. Bug 5733 applies.

Maintenance Asset Utilization Add/Update/Delete - WPMAN24 - Enhanced error handling to conform to DPAS standard. Bug 5783 applies.

Dispatch - WPMAN30 - Corrected the issue where the View Button on Dispatch screens is causing a system error. Remedy Ticket 102665 applies. Bug 5557 applies.

Contract Inquiry - WPMAN19 - Changed the "Cntr Name" label to "Cntrr Name" for process consistency. Remedy Ticket 102947 applies. Bug 5545 applies.

Equipment Utilization Form - WPMAN10 - Changed the DOD Serial Number validation to allow a hyphen as a valid character for the user to continue to use it as a search criteria. Remedy Ticket 103813 applies. Bug 5785 applies.

Auto Generate Work Orders (Background) - WPSAB52 - Corrected the logic to fix the issue where duplicate Work Orders are generated every day for a PM schedule, if a Schedule Before Days quantity is specified. With the fix, there should only be one Work Order generated per PM schedule, until the next Due Date is reached. Remedy Ticket 103951 applies. Bug 5963 applies.

Security

User Account History Inquiry - WPSEN06

- 1) Fixed the End Date on Search Criteria page so that the current date can be changed. Remedy Ticket 102715 applies. Bug 5255 applies.
- 2) Added History Remarks field to Search Criteria Page. Remedy Ticket 102720 applies. Bug 5522 applies.
