Web Release 2.3.00 for the Defense Property Accountability System (DPAS) effort was released on 31 October 2012. There is no action required by the user to receive the update.

---

System Change Requests (SCRs) in this release:

The following capabilities are provided with this SCR:

DPAS - 00327 - Attributes - This SCR is to provide for the Attributes functionality requirements added.

- **Stock Number / Selected Mass Update / Stock Number/Selected Mass Update Batch Background - WPCTN02 / WPSAB18** - Changed both processes to display Template/Attribute messages for the user when changing the Asset Category Code (ACC) of the Stock Number or changing from one Stock Number to another with different ACCs. Added the message, "Stock Nbr or ACC change may result in removal of template(s) and attribute value(s)".
- **Asset Update - WPHRN51** - Process modified to add attribute functionality.
- **Asset Transfer - WPHRN52** - Added additional logic to handle Attribute changes.
- **Attribute Add/Update/Delete - WPHRN75** - New process added to allow the Administrative Users of DPAS to configure and maintain the possible attributes of Assets.
- **Template Add/Update/Delete - WPHRN76** - New process added to allow the Administrative Users of DPAS to configure and maintain the attribute templates for each ACC.
- **Attribute Values Update - WPHRN77** - New process added to allow the Standard Users of DPAS to identify the specifics about a particular asset.
- **Asset Inquiry - WPHRQ14** - Modified the process to include attributes information added to assets. This allows the user to search and view attributes that are associated to the asset. Logic was added to Display Asset Attributes on Search Results grid and Detail pages.
- **Attribute Search Value Concatenation Function - WCDBG236** - New function added to concatenate Asset Attribute Values into one single searchable string and store the string in Attribute Template Asset Association Attribute Search Value.

- **Asset Identification Browse - WCGLM35** - Changed the browse by adding two new fields to display. The Display Attribute(s) checkbox field will allow users to toggle on and off the Attribute(s) information. The Attribute(s) text entry field will allow the users to search for Assets by their attribute value(s).
- **Smart Search Control - WCGLM60** - Added a new Common Search Control to allow users to Search with minimal data entry limitation. Search focus is on Asset Attributes and Attribute Value(s) e.g. Hard Drive 400 GB HP CDROM. Process should be able to break that search string into multiple search conditions and search field should expand as User types.
- **Asset Detail Viewer - WCGLX19** - Modified the viewer to display Attribute(s) and Template information that are associated to each asset.
- **Asset Attribute Values Search Common Function - WCGLX53** - Added new background process to use in conjunction with the Smart Search control. This process uses the data interpreted by the Smart Search Control and performs the actual logic to search against the database to find the matching records to display.

The following capabilities are provided with this SCR:

DPAS - 00327 - Authorizations - This SCR is to provide for the Army Authorizations requirements.

- **Authorization (LIN/TAMCN) Add/Update/Delete - WPAUN05** - Incorporated the File Attachment Control to be able to add or remove Attachments.
- **Cost Center Add/Update/Delete - WPAUN17** - Added the Attachment button to the screen so that attachments can be added or removed.
- **Generate DD1150 Request for Issue or Turn-In - WPHRN64** - Revised the Standard Form DD1150 according to specifications.
- **Attachment Add - WPUTN23** - Modified the process to include the capability to add and display Attachments in the Authorization LIN/TAMCN and Cost Center Add/Update/Delete processes.
- **LIN/TAMCN Authorization Report Request / LIN/TAMCN Authorization Report - WPAUR04 / WPAUR05** - New process added to request and print out the LIN/TAMCN Authorization Report.
- **Asset Summary Report / Asset Summary Report Request - WPAUR06 / WPAUR21** - New process added to request and print out the Asset Summary Report that includes the SB700-20 Army changes.
- **LIN/TAMCN Authorization Browse - WCGLM52** - Modified the browse to retrieve Authorization for all UICs for an Accountable UIC when more than one UIC exists for the LIN/TAMCN Authorization Report.

- **TDA Paragraph Number Browse - WCGLM59** - Modified the browse to retrieve Authorizations for all UICs for an Accountable UIC when more than one UIC exists for the LIN/TAMCN Authorization Report.
- **Improvement Personal Property Detail Viewer - WCGLX30** - Modified the viewer to show Authorization information when applicable for Attribute(s) functionality.

The following capabilities are provided with this SCR:

DPAS - 00327 CBSX - Enhanced the application to update UIT reporting including use of the LIN and adding the Out of Cycle request.

- **Request Custom Inventory - WPHRN32** - Added Standard Inventory capability with changes made to accommodate Army Personnel who manage property by LINs. Added LIN/TAMCN to search criteria to enable inventory by multi-select of LIN/TAMCN attached to personal property assets.
- **UIT Interface Transaction Report - WPHRR18** - Added the Substitution logic to this process so the report will be able to furnish the additional Substitution information. Also a Negative Reports area was added.
- **UIT Reconciliation Report - WPHRR40** - This new report is generated during the semi-annual UIT Recon or the UIT Out-Of-Cycle Recon processes. It displays all UIT Reportable Assets by UIC. Substitute and Negative records are included in the report.
- **UIT Out of Cycle Recon Request - WPHRR41** - The process will generate a batch record for each UIT Reportable UIC selected on the screen. The regular UIT Recon will then process the batch record(s) and generate a UIT Recon for specific UICs. A UIT file is created and sent to LOGSA.
- **UIT Daily Extract - WPUTG02** - Modified the process to enable substitution reporting.
- **UIT Recon Extract - WPUTG15** - Added a new process to allow new UIT Substitution data extracting capability. It writes the data to a flat file and to the Report table.
- **Actbl UIC/UIC Add/Update/Delete - WPUTN03** - Removed the call to UIT Common Function and managed System Setting according to standards. If System Setting is not found, then the UIT feature is not required.
- **UIT Reconciliation Background DAC Process - WPSAB27** - Requirement changes for CBSX Reporting.
- **UIT Substitution Daily Compare - WPSAB61** - Added a new background process to allow new UIT Substitution daily Scanning capability. It will write a substitution record if the Catalog LIN/TAMCN is different from the Authorization LIN/TAMCN.

- **UIT Substitution Recon - WPSAB63** - Added a new background process to allow New UIT Substitution Reconciliation capability. It will write a substitution record if the Catalog LIN/TAMCN is different from the Authorization LIN/TAMCN.

The following capabilities are provided with this SCR:

DPAS - 00327 Maintenance and Utilization - This SCR further updates the Maintenance and Utilization module adding Dispatch functionality and the inquiries, statistics and reports for the module.

- **Dispatch Journal Viewer - WPMAN22** - Modified the process to enable the user to view detailed dispatch activity entered into DPAS. It allows the user to view the life-cycle transactions of dispatches. It also provides the user with the ability to search transactions by various fields.
- **Dispatch - WPMAN30** - Modified the process to provide the DPAS user the capability to make a reservation for a sub-category of equipment, dispatch equipment and record the return of equipment at the end of its dispatch period.
- **Dispatch Statistics Inquiry - WPMAQ22** - New online inquiry screen added to view and display statistics for Dispatch.
- **Utilization Statistics Inquiry - WPMAQ24** - New online inquiry screen added to view and display statistics for Utilization.
- **Asset Type Statistics Inquiry - WPMAQ27** - New online inquiry screen added to view and display all the Asset Type Statistics collected based on period selected.
- **PM Schedules Statistics Inquiry - WPMAQ28** - New online inquiry screen added to view and display all the PM Schedule Statistics collected based on period selected.
- **Work Order Statistics Inquiry - WPMAQ29** - New online inquiry screen added to view and display all the Work Order Statistics collected based on period selected.
- **Work Plans Statistics Inquiry - WPMAQ30** - New online inquiry screen added to view and display all the Work Plans Statistics collected based on period selected.
- **M&U Statistics Inquiry - WPMAQ31** - Added a new online inquiry screen that will be the base screen for all Maintenance and Utilization Statistics Report searches. It will have all the parameter selections available to the user and it allows the user to select a particular Statistic Inquiry and the reporting date for the data to be shown.
- **Maintenance and Utilization Statistics Extraction - WCGLX49** - This process gathers all the statistical data and writes it into the correct

tables.

- **Vehicle Cost Accounting Report - WCUSS38** - A new Agency Predefined report. The purpose of this data extract is to provide the user with a listing of non-tactical vehicle accounting and management data with in the Agency.

The following capabilities are provided with this SCR:

DPAS - 00528 - Security Report of Privileged Users to support new system requirements.

- **User Account History Inquiry - WPSEQ06** - New inquiry added to show User Account History Status of all DPAS Users to include Application Security Officer privileged accounts.

This release contains the following Remedy Tickets / Bugs:

#### **Asset Management**

##### **Asset Inquiry - WPHRQ14**

- 1) Process modified to add the ECC field to the selection list. Remedy Ticket 100610 applies. Bug 1313 applies.
- 2) Added Authorization LIN/TAMCN as a selectable field to the inquiry. Remedy Ticket 101558 applies. Bug 4548 applies.
- 3) Deleted UIIs will no longer show on the Detail pages for the Asset. Remedy Ticket 100905 applies. Bug 4502 applies.

##### **Asset Update - WPHRN51**

- 1) Modified the process to successfully process price change of bulk assets by putting a value in LIN/TAMCN Key. This eliminates the "Bulk Update failed to select Bulk Record" error message. Remedy Ticket 101237 applies. Bug 4447 applies.
- 2) Modified the process to send total cost versus dollar amount to Component Viewer to eliminate the error that occurred during the conversion of ancillary. Remedy Ticket 100894 applies. Bug 1613 applies.
- 3) Corrected the issue of the user not being allowed to enter a dash in the LOT Number field. Remedy Ticket 101880 applies. Bug 4708 applies.

**Asset Transfer - WPHRN52** - The process is requiring users to access the Agency Tab prior to allowing them to commit a transaction even if the Agency does not specify any particular user defined file to be mandatory. Modified the process to check if Agency fields are required instead of making them always required. Bug 4388 applies.

**UII Update / Assignment - WPHRN56** - Modified the process so the user can change status from "E02" to another valid status via dropdown list on Search Screen. Added "ARN" and "ART" to the valid selection dropdown list on the Update screen. Remedy Ticket 100401 applies. Bug 1264 applies.

**Asset Disposition Reversal - WPHRN70** - The user reported an issue with not having access to Custodian under UIC. Modified the process to re-establish the Custodian to the User Property Custodian Property Table when the Custodian is reinstated. Remedy Ticket 100675 applies. Bug 1352 applies.

**TDA Paragraph Number Browse - WCGLM59** - Modified the process to correct the inability to assign Paragraph Numbers. Remedy Ticket 101053 applies. Bug 4431 applies.

### **Accounting**

**Improvement Add/Update/Delete - WPACN02** - Verified that moving the new Asset Code To value from Improvement process corrected the erroneous accounting transactions being generated. Bug 4428 applies.

**Real Property Add/Update/Delete - WPACN11** - Modified the process to correct improper handling of improvement accounting transactions. Remedy Ticket 101677 applies. Bug 4707 applies.

**Cost Center Mass Update - WPACB07** - Modified the process to update the duplicate record rather than abort when duplicate is found. Bug 917 applies.

**Accounting Control Common Function - WCGLX09** - Modified the process to stop erroneous accounting transactions from being generated from Improvements when the user updated the TASK / JON fields. Remedy Ticket 99219 applies. Bug 1078 applies.

### **AIT**

**PDCD Hardware Counts - WPHRQ31** - The process did not contain a column for displaying the CN3 scanners information. The statistics report was redesigned to list all scanners used by the Agency with the number of times used. Remedy Ticket 99974 applies. Bug 887 applies.

### **Authorization**

**Authorization Request - WPAUN02** - Made the UIC a mandatory field on the Search and Add functions. Remedy Ticket 100662 applies. Bug 4397 applies.

### **Catalog**

**Stock Number Inquiry - WPCTQ01** - Modified the process to add the Equipment Group Code field to the selection list. Remedy Ticket 100610 applies. Bug 1314 applies.

## **Maintenance and Utilization**

**Maintenance Inquiry Extract Viewer - WPUTR24** - The user experienced a server error message when clicking the inquiry hyperlink in the View Inquiry Extract process. Modified the program id to access the proper web page. Remedy Ticket 101736 applies. Bug 4613 applies.

## **Security**

**Security Login Validation - WPSEN01** - Added additional error tracking for error analysis. Bug 4443 applies.

**Site Id/Accountable UIC - WPSEN21** - Corrected the coding error that was eliminating access to Accountable UICs with a suspension date in the future. Remedy Ticket 101080 applies. Bug 1600 applies.

## **Supply Room**

**Issue Summary Inquiry - WPSRQ14** - Fixed the Supply Statistics Issues Summary Inquiry drilldown capability to present a new page. Remedy Ticket 100301 applies. Bug 951 applies.

## **Miscellaneous**

**DPAS Framework - WCGLM23** - Modified the DPAS Web Applications to display the correct release version number on screens per specifications. Bug 1086 applies.

**Scheduler ABCDL - WPSAN05** - Process modified to permit the following special characters. The valid characters are alphabetic "A" through "Z", numeric 0 through 9 and special characters ("(", ")", "\$, -, /, #, &, ", " (comma), "." (period) and " " space). Bug 914 applies.
