### **Release Notes**

Release 4.0.11 for the Defense Property Accountability System (DPAS) was released on June 22, 2016. This release corrects program deficiencies identified by the user community and through testing by the development teams. There is no action required by the user to receive the update.

  - Corrected a deficiency that caused Custodian-level users to be able to view other Custodian's data when searching within the Asset Transfer screen (Help Ticket #9736, 9737, 9751).

  - Corrected a deficiency that caused the user to receive an unexpected error when attempting to add a Sub-Custodian (Help Ticket #9493, 9507, 9637, 9817, 9859).
