#### 19 August, 2016

#### Release Notes

Release 4.1.10 for the Defense Property Accountability System (DPAS) was released on August 19, 2016. This release implements a number of System Change Requests and corrects a number of program deficiencies identified by the user community and through testing by the development team. The updates impact all 3 modules (Property Accountability, Maintenance and Utilization, and Warehouse Management).

#### Warehouse Management (WM) Module

The following Warehouse System Change Requests (SCR) were closed by this release:

#### SCR 887 Continuation - Inspection

This SCR requested the ability to provide the functionality to add a Quality Control request to a previously completed QC. It also requested the addition of the "QC Insepctor" column be added to the QC grid as well as a new QC Status of "Re-Look". Also included in this SCR was the addition of the QC Deficiency Inspection report which will be generated from the Report Manager.

### SCR 959 - Select All

This SCR requested the ability to have a "Select All" button on the Inventory Master Selector to easily and quickly select multiple items.
