Release Notes Overview

Release 4.1.20 for the Defense Property Accountability System (DPAS) was released on September 23, 2016.

This release implements several System Change Requests and corrects a number of program deficiencies identified by the user community and through testing by the development team. The updates impact 2 modules (Warehouse Management and Maintenance & Utilization).

Warehouse Management (WM) Module

Help Tickets

The following Warehouse Help Tickets were closed by this release:

Receiving (LPWHN19)

Help Ticket #11107, #11560

- Corrected a deficiency that caused the user to receive an invalid Validation message when receiving an item.

Help Ticket #11560

- Corrected a deficiency that caused the user to be kicked out of the Receiving process when attempting to use the Backspace key within the Serial Number Field

Member Profile AUD (LPWHN25)

Help Ticket #10386

- Corrected a deficiency that cause the user to be unable to create a new Member Profile record when trying to use their own EDIPI as opposed to the auto-generated one, or one pulled from the Personell Master record.

Individual Issue (LPWHN32.1)

Help Ticket #8359

- Updated the process to display the additional column on the Individual Issue grid titled "Stock Number Qty" and "Total Items Qty". Stock Number Qty is now the count of distinct stock numbers issued, while Total Items Qty is the total number of items issued. The two quantities will be the same if the person was issued only 1 of each stock number. They will be different if the person received more than 1 of any stock number(s).

Member Logon (LPSEN10)

Help Ticket #10113

- Corrected a deficiency which caused the Outstanding Returnable Items receipt to display no items when the user has a member profile record in two Logistics Programs with issues completed in only one of them.

Material Release Order (LPWHN35)

Help Ticket #10890

- Corrected a deficiency that caused the data fields related to Shipping an MRO to be empty, grayed out, and unable to be modified.

Help Ticket #11220

- Corrected a deficiency that processed MROs are no longer being displayed on the Material Release Order tab on the Warehouse Dashboard.

Set Kit Outfit - Disassemble (LPWHN42)

Help Ticket #11050

- Corrected a deficiency that made users unable to disassemble a managed bulk SKO item.

Unit Returns (LPWHN47)

Help Ticket #8340

- Corrected a deficiency that allows the user to view the DPAS Validation for the Location field prior to signing for the return to avoid completing the Return and being told the Location field is required.

Help Ticket #11227

- Corrected a deficiency that was causing a single component to be treated as an end item and being marked for Return Later when the user had the item in the kit being returned.

Inventory Update (LPWHN52)

Help Ticket #11367

- Corrected a deficiency that caused the in-correct Inspection Dates to be displayed for the Inventory Control Number (ICN).

Help Ticket #10722

- Updated the process to allow the user the ability to modify Inspection Dates and/or Stock Number specific Dates on Inventory Update Manager.

Quality Control (LPWHN56)

Help Ticket #10755

- Corrected a deficiency that if only one Cost Center is associated with Quality Control, the system will auto-assign that cost center.

Help Ticket #11247, #11357, #11462

- Corrected a deficiency that was causing the Condition Code of assets to be in-correctly downgraded due to multiple ICNs for a single stock number having different due dates for their next inspection(s).

DW Form 05 (LPWHR11)

Help Ticket #10845

- Corrected a deficiency that was displaying different data for the quantity issued between the DW Form 05 Outstanding Returnable Items list produced within DPAS and the Member Site when a member was issued the same unmanaged kit more than once over multiple issues.

Warehouse Transfer (LPWHN43)

Help Ticket #11498

- Corrected a deficiency that caused the Warehouse Transfer grid to be empty for specific Warehouses due to the large number of Document Numbers that were generated within that Warehouse.

Stock Number AUD (LPCTN01)

Help Ticket #11566

- Corrected a deficiency that caused a system-wide slow down when trying to add a new Inspection Type to a Stock Number..
