Release Notes Overview

Release 5.1.30 for the Defense Property Accountability System (DPAS) was released on August 11, 2017.

This release includes corrections to program deficiencies identified by the user community. This update impacts Warehouse Management, Property Accountability, Maintenance and Utilization, and Material Management Module.

Warehouse Management Module

- Corrected a deficiency where DPAS Warehouse Module was in-correctly generating a AE_ followup reply for stock denials.

- Corrected a deficiency that caused an invalid Stock Item validation error to be displayed when attempting to complete a receipt for a Warehouse Transfer.

Warehouse Transfer (LPWHN43)

- Corrected a deficiency that caused the Inspection dates on an asset to be removed during the receiving process of a Warehouse Transfer.

Container AUD (LPWHN20)

- Corrected a deficiency that caused critical error to be displayed when searching or browsing for a container in a warehouse that contained no containers.

Individual Return (LPWHN46.1)

- Corrected a deficiency that caused the kits to be returned in the in-correct condition code when all components were present.

Unit Return (LPWHN34)

- Corrected a deficiency that caused the quantities to be doubled on certain items when conducting a Unit Return.

Reconcile Physical Inventory (LPWHN54)

- Corrected a deficiency that caused the user to be unable to edit multiple records on the Physical Inventory without needing to close out of the item.

- To meet the Air Force General Fund Trial Balance Report requirements, Critical Feeder systems provide proprietary general ledger data to the General Accounting and Finance System (GAFS). The Air Force Equipment Management System (AFEMS) provides a year-to-date reconciliation file for the Equipment and Accumulated Depreciation Accounts concurrently with a monthly detail file. The file will be used to reconcile the detail transaction to the yearly summary and identity processing problems.
