Release Notes Overview

Release 5.2.00 for the Defense Property Accountability System (DPAS) was released on September 29, 2017.

This release includes corrections to program deficiencies identified by the user community. This update impacts Warehouse Management, Property Accountability, Maintenance and Utilization, and Materiel Management Modules.

Warehouse Management Module

System Change Requests

The following Warehouse Management System Change Requests were closed by this release:

- SCR 0714 – Addition of the capability to transfer unit issued equipment from one UIC to another, from a UIC to a UIC/Account Name (Sub UIC), and UIC to Individual within the Warehouse and provide users the ability to print all receipt and return documentation.
- SCR 0849 – Inventory Activity Inquiry was upgraded to include the ability to search on the From Date and To Date field for all inventory changes within a warehouse.
- SCR 0950 – Inventory Activity Inquiry was upgraded to provide a more robust search criteria and inventory tracking at the Warehouse level.
- SCR 1028 – Provide the capability within the Warehouse Module to conduct Physical Inventories of Issued Materiel. The capability includes Unit and Individual Issued Items. Users will be able to auto-schedule the inventory, establishing the frequency, as well as manually schedule the Inventory.
- SCR 1029 – Provide the capability for the Warehouse Module to schedule and conduct an assessment review. Users will be able to auto-generate an assessment for items Received into the warehouse and for items being Returned from an Individual/Unit/Armory issue. These assessments will be generated in the current Quality Control process and allow the users the ability to replace components with the kits as part of the assessment. Items replaced can be disposed of, or put back into stock. Appropriate inventory transactions will be generated for the actions taken.
- SCR 1030 – Inventory Activity Inquiry was upgraded to provide a more robust search criteria and inventory tracking at the Warehouse level.
- SCR 1031 – Capability to report activity by any User or Warehouse by a specific Date that will allow the user to view all of the activity within those parameters.
- SCR 1068 – Provide the ability to ship multiple stock numbers within the warehouse transfer process and provide the ability to view and print the DD Form 1149.
- SCR 1079 – Upgrade the Manage SKO pop-up within the Quality Control process to allow increased functionality directly through the QC process.
- SCR1092 – Addition of the Quality Assurance (QA) Inspection Type that will be added to the Quality Control process and function the same way as the QC process.
- SCR 1119 – Recommend having Individual and Unit Issues process associated with the Warehouses that conduct the Issues to better track inventory activity.

- SCR 1140 – Inventory Activity Inquiry was upgraded to provide a more robust search criteria and inventory tracking at the Warehouse level (inventory movement transactions).
- SCR 1141 – Inventory Activity Inquiry was upgraded to provide a more robust search criteria and inventory tracking at the Warehouse level (inventory adjustment transactions).

Maintenance and Utilization Module

System Change Requests

The following Maintenance and Utilization Module System Change Requests were closed by this release:

- SCR 0845 – Addition of the Longitude and Latitude fields to the DPAS M&U module to allow for proper FAST reporting.
- SCR 0982 – Recommended when all NSNs have an ACC value of “P”, modify the user interface to only show “Vehicle” as the only Attribute value that is available for FAST reporting.
- SCR 0983 – Addition of the ability to record and report the U.S. state where vehicle re-fueling takes place by adding the “Fuel State” field as a drop-down selection box to the Maintenance Asset Utilization and Dispatch Return Utilization.
- SCR 0945 – Recommended for assets with a Fuel Association of “Electric” only, M&U needs to provide the ability to capture the electricity (kWH) consumption for FAST Reporting.
- SCR 1039 – Addition of new data elements to meet the requirement for FAST Vehicle Level Reporting Out Year Vehicle Acquisition, Disposal, and Fleet Cost.
- SCR 1052 – Recommended adding the “Location Withheld” field to allow FAST users the ability to designate that the vehicle location be withheld for specific vehicles.
- SCR 1053 – Recommended adding the Petroleum Dedicated LGHG Vehicle Qualifying as AFV that is used to identify for FAST Reporting.

Notes

The following notes are deemed important to the DPAS user community and will be affected by this release:

- Aging of DPAS user accounts will now be as follows:
 - a. From 15-34 days of inactivity – A system generated email is sent daily requesting the user to log in to his/her account to remain active.
 - b. From 35-180 days of inactivity – A system generated email is sent daily confirming the DPAS account has been suspended. The user must contact the DPAS Support Desk and request an account reset. Once the reset is complete, the user must login within 5 day(s) after the reset or the account will be suspended again due to inactivity.
 - c. At 181 days of inactivity – The user's account is deleted. Email is sent to the user confirming deletion of the account. If access is required, all new paperwork must be submitted.
 - d. At 181 days, Non-Authentication (Never logged in) – The user's account is deleted. Email is sent to the user confirming deletion of the account. If access is required, all new paperwork must be submitted.
- To comply with DoD requirements, session termination will now occur after user has been inactive for 15 minutes, at which time the user will need to reestablish a new session if he/she desires to continue working in the application.
