Release Notes Overview

Release 5.2.10 for the Defense Property Accountability System (DPAS) was released on October 20, 2017.

This release includes corrections to program deficiencies identified by the user community. This update impacts Warehouse Management, Property Accountability, Maintenance and Utilization, and Materiel Management Modules.
