## Release Notes Overview

Release 5.2.30 for the Defense Property Accountability System (DPAS) was released on December 15, 2017.

This release includes corrections to program deficiencies identified by the user community. This update impacts Warehouse Management, Property Accountability, and Maintenance and Utilization Modules.

## Warehouse Management Module
