Release Notes Overview

Release 5.1.10 for the Defense Property Accountability System (DPAS) was released on June 02, 2017.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts Warehouse Management, Property Accountability, Inventory Control Point, and Maintenance & Utilization Modules.

Warehouse Management Module

System Change Requests

The following Warehouse Management System Change Requests were closed by this release:

- SCR1118 - DPAS was updated to include the two new return reason codes to the Individual and Unit Return processes: GA - FLIPL DD-FORM 200/Govt Authorized and GR - FLIPL DD-FORM 200/Govt Reimbursed

- Corrected a deficiency that caused the users to be confused with the “Ready for QC” status when the status should have been “Closed.”

- Corrected a deficiency where components would drop from kits in QC when the QC job ran/created QC records..

Receiving (LPWHN19)

- Corrected a deficiency that caused the stock number database key to be displayed in the Stock Number field and did not allow the user to complete the transaction.

Released 5.1 SAT Defect #50

- Corrected a deficiency that allowed the user to receive a non-contracted asset in a contract mandatory Warehouse.

Inventory Update (LPWHN52)

- Corrected a deficiency that allowed an item to be moved to an Individual Issue Location or Container with a Condition Code less than 'A'.

Help Ticket #14412

- Corrected a deficiency that did not allow the users the ability to change a Stock Number from Unmanaged to Managed within Inventory Update.

Master Issue List AUD (LPWHN22)

Help Ticket #12895

- Corrected a deficiency that the UICs assigned to Master Issue List to be dropped when adding a new UIC.

Individual Returns (LPWHN46)

Help Ticket #13337

- Corrected a deficiency that caused an error when attempting to add a attachment that contained special characters in the attachment description in the Individual Return process.

Container (LPWHN20)

Help Ticket #13878

- Corrected a deficiency that caused an error when attempting to add a new container to a warehouse that has been deleted in a different warehouse.

Stock Item AUD (LPWHN10)

- Corrected a deficiency that caused multiple users to receive decreased performance when attempting to add stock numbers to the Stock Item AUD.

Equipment Type AUD (LPCTN18)

- Corrected a deficiency that caused multiple users to receive decreased performance when attempting to add stock numbers to the Stock Item AUD.

Inventory Master Selector (LCGLM16)

Help Ticket #14417

- Corrected a deficiency that caused the Inventory Master Selector to only display component inventory that was currently in the same location as the header. This change will allow components to be added through the Inventory Master Selector regardless of where they are currently being stored.

Set Kit Outfits Assemble (LPWHN41)

- Corrected a deficiency that caused the user to receive a critical error when attempting to assemble a kit.

Corrected a deficiency that caused an error when removing the shelf life extension.

DW Form01 (LPWHR07)

- Corrected a deficiency that would show the Inspections based on whether the Location was a Deployed Location or not.

DW Form05 (LPWHR11)

- Corrected a deficiency that improved the performance of the download time for the DW Form 05.

Unit Issue (LPWHR07)

- Corrected a deficiency that caused the Status field in the Search Criteria to be defaulted to 'X-Cancelled' and not the standard 'All Open'.
