Web Release 2.5.00 for the Defense Property Accountability System (DPAS) effort was released on 13 March 2014. There is no action required by the user to receive the update.

System Change Requests (SCRs) in this release:

DPAS - 00349 - Multiple Signature Blocks on Inventory Report - This SCR enables users to build multiple signature blocks for Inventory Reports and provides a drop down list of these options when generating the Inventory Reports. This eliminates the need to repeatedly re-create / update multiple signature blocks as required. It gives users the flexibility to produce messages as well as the signature blocks on the reports.

- **Agency Settings Update - WPUTN09** - Modified the process to allow the user to create multiple signature blocks for the Inventory reports and also provide a drop down list of these options when generating the Inventory reports. This eliminates the need to repeatedly update the signature blocks and it gives the ability to change the default Signature Block.
- **Generate/Reprint Inventory Report - WPHRR33** - Modified the process to allow the user to change the Signature Block when re-printing the report and offers the user the option to select the condensed version of the report.

Modified the process to allow the user to create multiple signature block options for the Inventory Reports and provided a drop down list to select the appropriate option when generating the Inventory Reports. This eliminated the need to repeatedly update the signature blocks. The following inventories and processes are affected:

- **Request Custom Inventory - WPHRN32**
- **Request Custodian Inventory - WPHRN65**

DPAS - 00413 - Custodian Inventory Listing Redesign - This SCR recommends improving the Custodian Inventory Report printing capacity, cost and efficiency. It reduces the report size and time required to review the report by reducing the number of pages printed. This was accomplished by changing the font size, removing the repetitive header information after the first page and removing the bold line dividing each asset record. By adding a second level sorting sequence, the report can be reviewed in a more organized method. A sub-total and cost line were inserted when a report is printed in "Item Description" or "Location Sort" sequence to provide a better presentation of the account contents. The report is mission critical to the Inventory process and a vital maintenance instrument for up-keep of the Property Book records. It is used frequently to provide relevant instantaneous Change of Custody information to the Custodian Holder.

- **Custodian Inventory Report - WPHRR01** - Created a new standard condensed report to view / print the information for more than 6 assets per page, sorted the report data by a second level so that the report is easier to read and inserted a line for sub-total and cost for each Stock Number.
- **Generate/Reprint Inventory Report - WPHRR33** - Modified the process to allow the user to change the Signature Block when re-printing the report and offers the user the option to select the condensed version of the report.

DPAS - 00547 New Asset History Process (Phase I) - This SCR creates a new process to enhance the Asset History for all users and reduce the number of calls made to the DPAS Call Center. Phase I consists of data gathering and collection in anticipation of permitting the user to view their history transactions in the Property Accountability (PA) Modules in a more concise, accessible/understandable manner. The following processes were modified to support the Asset History process:

- **Ancillary Cost Add/Update/Delete - WPACN01**
- **Improvement Add/Update/Delete - WPACN02**
- **CIP Asset/Improvement Add/Update/Delete - WPACN16**
- **Asset Transfer - WPHRN52**

DPAS - 00548 Warehouse Initiative/CSP - This SCR encompasses the changes within the Maintenance and Utilization (M & U) Modules necessary to prepare DPAS to interface with the Warehouse System/Module. Integration with the Warehouse System/Module allows the M & U users to record maintenance activities for Warehouse assets in addition to PA assets.

- **Work Plan Add/Update/Delete - WPMAN08** - Modified the process to display additional asset data used by the Warehouse Module, as well as new "Inspection" Work Order data. Modified to use the browse to make Work Plan Associations and write them to the data base table.

- **Work Order Add/Update/Delete / Work Order Status Outbound Common Function / Work Order Browse - WPMAN12 / WCGLX58 / WCMAM07** - Modified the process to accommodate Care of Supply in Storage (COSIS) processing and reporting updates to the Warehouse Application. Added a new common function to communicate Warehouse statuses and Work Orders data. Modified the browse to search for Asset and Catalog data in the Warehouse Module in addition to the PA Module.
- **Maintenance Actions Add/Update/Delete - WPMAN15** - Modified the process to include maintenance of assets managed by the Warehouse Module in addition to assets that are managed within the PA Module. Added a new Work Order category to identify all Rejected Inspection work.
- **Journal Viewer - WPMAN22** - Modified the process to display additional asset data that is appropriate to the Warehouse, as well as new "Inspection" Work Order data.
- **Asset Movement Request - WPMAN36** - New process to allow maintenance users to request movement of warehouse assets from storage locations to maintenance locations.
- **Work Plan / Warehouse Stock Number Association Add/Update/Delete - WPMAN37** - Modified the process to allow the linking of Work Plans to Warehouse-based Stock Numbers so Work Orders created as a result of Warehouse requests can automatically populate the Work Plan.
- **Asset Preventive Maintenance Schedule Inquiry - WPMAQ08** - New inquiry added to search and display Operator/Technician/Quality Control (QC) personnel data.
- **Operator Technician Inquiry - WPMAQ33** - New inquiry added to search and display Operator/Technician/QC personnel data.
- **Upcoming Work Report Request / Upcoming Work Report / Upcoming Background Batch - WPMAR19 / WPMAR20 / WPSAB64** - Modified the Work Order Form to display additional asset data from the Warehouse, as well as new "Inspection" Work Order data and added a new background process.
- **COSIS Generator Report Request/ COSIS Generator Report Request Report - WPMAR21/WPMAR22** - New process to generate a Standard Form for creating and displaying COSIS inspections data that needs to be completed.
- **External Maintenance Inbound Interface - WPMAB01** - New background process developed to import Assets, Work Order Requests and Statuses from DPAS PA, Warehouse and M & U Modules. The process automatically runs every 15 minutes as a part of the DPAS Administration Console (DAC) Job.
- **Work Order Status Inbound - WPMAB03** - New M & U Module background process to update Work Order data. This process is a part of the DAC Job for WPMAB01.
- **Work Order Generator - WPMAB04** - New background process developed to insert Work Order records and, when necessary, Maintenance Asset Master (MAM) data into the M & U Module.

- **Work Order Insert Function Background - WPMAB05** - New background process developed to insert Work Order records and, when necessary, MAM data in the M & U Module.
- **Work Order Status Update Background - WPMAB06** - New background process developed to update Work Order Statuses in the M & U Module. This process works similarly to that of Work Order Status Inbound with the exception that this process is not a part of a DAC job. This process is a part of the Windows Service that automatically runs approximately every 15 seconds.
- **Work Plan Catalog Base Browse - WCGLM58** - New browse added to pull data from the DPAS Work Plan Catalog data base tables to prepare for processing by Work Order Insert Function Background for Warehouse Catalog Association records.
- **Work Order Insert Stored Procedure - WCGLS01** - New stored procedure added to be used with Work Order Insert Function Background.
- **Work Order Status Inbound Stored Procedure - WCGLS02** - New stored procedure added to be used with Work Order Status Update Background.

DPAS - 00550 - User Account Inquiry Display of results for non-PA Users Only - This SCR provides the User Id drill down functionality to reveal the user's granted module to non-PA Module users. Currently on the User Account Inquiry Search Results screen, the User Id drill down functionality does not include any information about the user's account and has no way to see the user's Access Level. This is used by the Accountability Property Officers (APOs), DPAS Account Management and Application Administrator User Types to view and verify the user's granted access and Assigned Maintenance Activity and/or the Supply Store for the Supply Store, M & U and Warehouse Modules Level of Access for Updates, Reports and Inquiries.

- **User Status Inquiry - WPSEQ05** - Modified the process to display and navigate columns showing the Access Levels appended to the displayed information. Access Level Values will differ depending on what application information it is applied to. PA Access Level Codes are pulled from the user_site table and for M & U from the user_maint_activity table and for Supply Store from the user_supply_room table. The report display will come from the appropriate look-up tables based on the Access Level Code.

DPAS - 00560 - Interface with DLA Transaction Services for list of Department of Defense Address Activity Codes (DoDAACs) (Phase II) - This SCR provides the creation of a new inquiry to review and/or print the data retrieved from the interface that automatically synchronizes with the DLA Authoritative Data Server and populates a mirrored Data Store inside the DPAS domain. The DoDAAC File is the system of record for both DoD and Contractor DoDAACs. DPAS should pull from the Department of Defense Address Activity File (DoDAAF) rather than requiring a manual entry to be processed.

- **DODAAC Inquiry - WPUTQ13** - Created a new inquiry to review and display DODAAC information.

DPAS - 00564 - Information Technology (IT) Software License Management (Phase II) - This SCR develops a process that allows for assigning, tracking, verifying and identifying the software names, versions, number of licenses, machine installations, etc. The Dashboard displays remaining licenses, warnings when licenses are about to expire, etc. and establishes a way to track the purchase, issue and software license disposition. Benefits of implementing would allow more accurate tracking that will improve software usage accuracy and accountability and not just the ownership. It allows management to see when the software is being utilized and by whom. Decisions could then be made on purchasing more software copies, warranties, upgrades and etc. It issues an alert when a license or warranty nears expiration, for scheduled upgrades and agency-defined license threshold (i.e. 90% licenses issued). It improves management and budgeting efficiency. Software module must have Add, Update and Delete functionality. Each process must have mass capabilities.

- **File Upload - WPACN20** - New process added to upload IT Software License Management Files.
- **PA My Actions / PA My Actions Definitions - WPACN29 / WCGLX02** - Modified the process to display IT Software License Management information.
- **IT Device Software Add/Update/Delete - WPITN02** - Modified process to allow for IT File Upload processing.
- **IT Asset Characteristics - WPITN08** - New process added to allow the user to add, update and delete characteristics to IT Assets. These characteristics will enable the file upload process to match Property Book assets with assets uploaded from a network scan tool.
- **IT File Upload Exception Report - WPITR01** - New report added to display and print errors that require correction.
- **Asset Id Browse - WCGLM35** - Modified the browse to search for IT Assets across UICs when coming from the IT Asset Characteristics (WPITN08) process.

DPAS - 00568 - Document Number Sequencing - This SCR prevents the same Document Number being used for different transactions types. The Document Number will be unique by UIC and Type.

- **Document Number Validation - WCGLM20** - New process to validate the entered Document Number and ensure it is in UIC and Type sequencing order to prevent duplicates.

The following processes were modified to support SCR 568 - Doc Nbr Sequencing. This is to make the change requested by the Army users. They want Document Numbers unique by UIC and Type. This is to avoid the same Document Number being used by two different users for different types of transactions.

DPAS - 00580 - Equip Utilization Sort Enhancement - This SCR adds a sort sequence in the print process to sort by the following categories for the Equipment Utilization Form: Office, Dispatch Category or Equipment Pool. Without the sort, currently this causes the user to manually sort over 1,200 utilization forms every month into their correct Sub Category (Office), this is very time consuming. This reduces cost by lowering the man hours it currently takes to sort the forms, improves accuracy and efficiency.

- **Equipment Utilization Form Request/Equipment Utilization Form - WPMAR09/WPMAR10** - Modified the form so it can be generated, reviewed and or printed by sorting on the Dispatch Category, Sub-Category and/or Equipment Pool.

DPAS - 00587 - Capital Asset Threshold - This SCR increases the Capital Threshold. It affects all Agencies. The Capital Threshold is being reviewed by the OSD Comptroller. The current language in the modification will permit each Agency or Service to establish a threshold for General Equipment and Real Property. For DPAS, this means the Agency Code needs to be added to the Capital Threshold Table and subsequent processes. This modification of the Capital Threshold will be effective October 1, 2013 (FY2014) and will not be back dated and affect any previous years/assets. Per Memorandum entitled, "Elimination of Military Equipment Definition and increase to Capitalization Thresholds for General Property, Plant and Equipment", to increase Capitalization Threshold from \$250,000 to \$1 million for Department of Air Force and Department of the Navy GE general fund assets. Also, Real Property needs to be increased to \$200,000.00. The following processes were modified to complete this SCR:

DPAS - 00602 - M & U Warranty/Service/Subscription Issue - This SCR affects all M & U users who use the Work Order process. This SCR recommends only display those contracts that were specifically associated to the asset on the Work Order.

- **Work Order Add/Update/Delete / Work Order Status Outbound Common Function / Work Order Browse - WPMAN12 / WCGLX58 / WCMAM07** - Modified the process to accommodate COSIS processing as well as sending outbound transactions to the Warehouse Application. Added a new common function to communicate Warehouse statuses and Work Orders data. Modified the browse to search for Asset and Catalog data against the Warehouse Module in addition to data within the PA Module.

- 2) Fixed the process to correctly update the increase and decrease flags so that when a Loan Update is performed, it will process, generate and/or print an accurate increase/decrease report. Remedy Ticket 106862 applies. Bug 8289 applies.

Attribute Add/Update/Delete - WPHRN75 - Fixed the process to allow the user to properly delete or re-add a previously deleted attribute. Remedy Ticket 107144 applies. Bug 8314 applies.

Asset Inquiry - WPHRQ14 - Fixed the inquiry to show and indicate the correct associated Authorization and/or Catalog LIN to the asset. Remedy Ticket 107041 applies. Bug 8320 applies.

Line of Accounting (LOA) Browse - WCGLM17 - Changed the process to clarify and display a more detail specific EBAS Interface accounting error message when the Object Class Code should be assigned when the LOA is not built.
