Web Release 2.6.00 Emergency 1 for the Defense Property Accountability System (DPAS) was released on 31 October 2014. This release corrects Remedy tickets which document issues reported by the user community, System Change Requests (SCRs) which update program functionality and program deficiencies identified by the user community and development teams' testing. There is no action required by the user to receive the update.

### Property Accountability (PA) Module

#### System Change Requests (SCRs) in this release:

DPAS - 00589 - Wide Area Work Flow (WAWF) Permit Multiple Product/Service Identification (Id)

**Background** - Prior to Release 2.6.00, WAWF only sent one Product/Service Id Number to DPAS in its XML Schema and DPAS only accepted one Product/Service Id Number. In November FY14, WAWF will implement a change in their 5.6 Software Version which permits up to 15 Product/Service Id Qualifier and Product/Service Id pairs on a WAWF Property Transfer Document. The Fed 956 IC, Version 4010 accommodates 15 such pairs. In order to make this change, WAWF is renaming and validating WAWF data elements and updating their XML Schema to allow for multiple Product/Service Ids so that files flowing in and out of DPAS do not fail compliancy. This facilitates import of new Assets into the Government Furnished Property (GFP) System semi-automated process. It allows the system to pre-populate more data and reduces user's data entry time.

This SCR includes the following:

- Updated Inbound XML File Reader to point to newest XML Schema Version
- Updated Outbound XML File Creator to use newest XML Schema Version for creating XML Files
- Updated WAWF Inbound and Outbound processes to use newest data element names
- Updated WAWF Outbound processes to populate more data information by using more Product/Service Identification information
- Updated WAWF Inbound process to use all of the new inbound data to update existing Assets or receive new Assets (depending on the Transfer Transaction Type)

WAWF Inbound XML Import - Modified for new WAWF schema changes.
WAWF Inbound AS Processor - Modified for new WAWF schema changes.
WAWF Inbound TS Processor - Modified for new WAWF schema changes.

**WAWF Export -** Modified code to use new WAWF 5.6 Schema to pull data off the WAWF Outbound table to create XML files to send to WAWF.
