Release 2.6.02 for the Defense Property Accountability System (DPAS) was released on January 06, 2015. This release corrected program deficiencies identified by testing conducted by the user community and the development teams. There is no action required by the user to receive the update.

Property Accountability (PA) Module

General

- Corrected a deficiency which caused timeout errors in numerous processes (Remedy #113869, 107467, 111591).

Asset Update

- Corrected three deficiencies which caused runtime exceptions for the user.
- Corrected a deficiency which caused "Error 83 - Unknown Error" when doing a search (Remedy #113912, 113914).

Accounting - Depreciation Update

- Corrected a deficiency which only allowed a mass update when stock number and activation date match (Remedy #112980).

Inventory Inquiry Process

- Corrected a deficiency which caused an unexpected error in the Custom Inventory Inquiry (Remedy #113291).

SB700-20 DPAS Administrative Console (DAC) Process

- Corrected a deficiency which was preventing the SB700-20 background process from running.

Construction in Progress (CIP) Project Inquiry

- Corrected a deficiency which caused the CIP Project Inquiry to perform poorly and produce timeout errors.

Disposition

- Corrected a deficiency in the Item Unique Identifier (IUID) Outbound process which prevented Dispositions from delivering output to the IUID registry.
- Corrected a deficiency which left an empty file in the outbound directory when the process failed.

Asset Increase / Decrease Report

- Corrected a deficiency which caused the report to error when submitted for generation.

AIT Physical Inventory

- Corrected a deficiency which prevented the user from re-downloading the inventory to the scanner (Remedy #112781).

Warehouse Management (WM) Module

Stock Nbr

- Stock Nbr Add/Update/Delete (AUD) - Corrected a deficiency which involved verifying the Agency code against the FEDLOG service prior to listing it as an available stock number for import through FEDLOG (Remedy #114086).

Master Issue List

- DW Form 03 - Corrected a deficiency which involved the incorrect quantity being displayed on the DW Form 03.
- Corrected a deficiency identified in Production in which Internet Explorer caused the Master Issue List page to display a "stop running script" prompt (Remedy #114103).
- Process was updated to increase performance within the Unit Identifier Code (UIC) grid on the Master Issue List when the grid contains greater than 10 UICs and paging has occurred.

Individual Issue

- Corrected a deficiency which involved a critical error to be display when cancelling an individual issue.

Material Release Order

- Corrected a deficiency which occurred when completing a pick for managed kits, the kit header Item Control Number (ICN) could be added to the document transaction record more than once.

Transportation Plan/Pick

- Corrected a deficiency where the Add button was displayed in the Transportation Plan/Pick Process when logged in as a read-only user (Remedy #113563).

Receiving

- Corrected a deficiency identified during user training which would not allow the user to accept a Receipt due to validation error.

Stock Control System (SCS)

- Defense Logistics Management System (DLMS) Transaction Activity - Corrected a deficiency in which the Document Identifier Code (DIC) was not written to the outbound table and transmitted to SCS.

Sets, Kits Outfits (SKO) Catalog

- Corrected a deficiency in which the value for the Kit Managing Shelf Life field was set incorrectly.

Shelf Life Extension

- Corrected a deficiency in which the system allowed the addition of a record on the Shelf Life Extension AUD when the record was non-extendable.
