Release 3.1.10 for the Defense Property Accountability System (DPAS) was released on October 02, 2015. This release corrects program deficiencies identified by the user community and through testing by the development teams. There is no action required by the user to receive the update.

Interface

- WPHRI08 - LIMS-EV Export
  - DPAS Property Accountability module was updated to produce a scheduled extract of selected DPAS data that is sent to the Air Force Logistics, Installation, and Mission Support Enterprise View (LIMS-EV) system for further processing (SCR #00733).

**Warehouse Management Module:**

AIT Process Receiving

- LPAID07 - AIT Process Receiving
  - Corrected a deficiency that caused the user to receive a mandatory validation entry on the UII Status field. This occurred when uploading assets, even when they were associated to UIIs (Help Ticket #3653).

Inactive Users Report

- LPSER02 - Inactive Users Report
  - Corrected a deficiency which prevented the Inactive Users Report from correctly displaying all the inactive users (Help Ticket #3587).
  - Corrected a deficiency which prevented deleted users from appearing on the Inactive User Report after they were deleted (Help Ticket #3053).

Individual Returns

- LPWHN46.1 - Individual Returns
  - Corrected a deficiency which caused the user to receive a JavaScript error while attempting to verify a kit on the Individual Return grid (Help Ticket #3556, #3684).

Receiving

- LPWHN19 - Receiving
  - Corrected a deficiency which caused the incorrect Condition Code to be set on the Receiving screen while verifying the components of a kit. The validation code was modified to ignore the missing components, which are optional on the Set, Kit and Outfit (SKO) Catalog; allowing the kit to be marked as Complete (Help Ticket #3578, #3579).
  - Corrected a deficiency which prevented closing the Receiving document after the Quality Control was completed and passed (Help Ticket #3536).

#### Print Label

- LPWHN65 - Print Label
  - Corrected a deficiency that caused the user to receive a JavaScript error after selecting the Label button from within the DPAS application (Help Ticket #3702, #3636, #3833).

#### Disposition

- LPWHN50 - Disposition
  - Corrected a deficiency which caused the user to receive a JavaScript error when attempting to approve a Disposition from the approval pop-up from within Disposition (Help Ticket #3733).

#### Project Management

- LPWHN14 - Project Management
  - Corrected a deficiency that caused the user to receive a JavaScript error when attempting to plan the project (Help Ticket #3595).

#### Materiel Release Order

- LPWHN35 - Materiel Release Order (MRO)
  - Corrected a deficiency which caused the user to receive a validation message stating the entire available inventory was already allocated, even though it was allocated to the Project Code the MRO kit was attempting to use. The code was modified to have the Requisition Project Code pull from inventory based on the Project Code established in the MRO (Help Ticket #3629).

#### Fiscal Year Rport

- LPWHR15 - Fiscal Year Report
  - Corrected a deficiency which caused the Fiscal Year report to return the incorrect values for each warehouse (Help Ticket #4017).

### General

- Instructions
  - Updated all pages that included a reference to an outdated URL in the instructions for the Cage Code field (Help Ticket #3657).

### Asset Activity Inquiry

- WPHRQ20 - Asset Activity Inquiry
  - Corrected a deficiency which caused the user to be unable to execute the Asset Activity Inquiry due to a server timeout error being received (Help Ticket #3570).

### Asset Inquiry

- WPHRQ14 - Asset Inquiry
  - Corrected a deficiency which caused the displayed row count and ordering of the data within the Excel report to be incorrect (Help Ticket #3387, #3403).

### GSA File Upload

- WPMU02 - General Services Administration (GSA) File Upload
  - Corrected a deficiency which prevented completion of the FY16 GSA Rates file upload (Help Ticket #3553).

### View Forms/Reports

- WPUTR01 - View Forms/Reports
  - Corrected a deficiency which caused display of an incomplete list of the reports generated over the past 30 days when the Report Name hyperlink is selected. The user is unable to select the report name to see a list of all past Inactive/Canceled reports (Help Ticket #3032).

- Access Role
