Release 3.1.12 for the Defense Property Accountability System (DPAS) was released on November 13, 2015. This release corrects program deficiencies identified by the user community and through testing by the development teams. There is no action required by the user to receive the update.

 - o Corrected a deficiency which caused the user to receive an error message when attempting a cost correction on a capital asset. The error was caused when attempting a price update on a component of the asset (Help Ticket #3420, #3679).

 - o Corrected a deficiency which caused the Sub Custodian Number to not display correctly in Block 3 of the DD1150 (Help Ticket #5254).

 - o Created a new role called 'Custodian with Reconcile' (Help Ticket #4228).

 - o Corrected a deficiency which caused the user to receive error messages when attempting to add a major custodian or sub custodian (Help Ticket #3888).

 - o Corrected a deficiency which caused the process to fail when attempting a site-to-site transfer of an asset (Help Ticket #5390).

 - o Corrected a spelling deficiency on the History Remarks field to match the DPAS standards (Help Ticket #3812).

Quality Control Management

- LPWHN56 - Quality Control Management
 - Corrected a deficiency that caused the users to receive an "Empty Allocations" validation message when attempting to mark the asset as damaged (Help Ticket #4062, #5287).
 - Modified the process to allow users to view attachments even after the Quality Control request has been completed and is in a closed status (Help Ticket #5654).

Individual Issue

- LPWHN32.1 - Individual Issue
 - Corrected a deficiency that allowed the users to cancel the issue while waiting for the Issue Receipt to display even though issue was already complete. This would cause the members Outstanding Items receipt to not show the correct issued items and the inventory reflect the items as issued (Help Ticket #4068).
 - Corrected a deficiency which caused the user to receive an error when selecting the Verify Kit button (Help Ticket #5436).

Individual Return

- LPWHN46.1 - Individual Returns
 - Corrected a deficiency wherein the return date on the receipt shows the date the return was initially created as opposed to the date it was completed and signed for. The receipt now shows the date the return was completed, if different than originally started. Bug was found during internal testing for this release, and was found to exist in the existing production version.

Inventory Master Selector

- LCGLM16 - Inventory Master Selector
 - Corrected a deficiency which caused the user to be unable to select the desired asset from the Inventory Selection grid after entering the serial number in the search and selecting the Search button. (Help Ticket #4119).

Materiel Release Order (MRO)

- LPWHN35 - Materiel Release Order
 - Corrected a deficiency which caused the user to receive an error when attempting to update the Shipped fields on the Materiel Release Order (Help Ticket #5260, #5481).
 - Corrected a deficiency wherein the project code included on an inbound DLMS MRO request was incorrectly used to determine stock levels available to satisfy the request. Fix was to include the warehouse getting the MRO request and the project status in the search for projects to determine if the project code on the MRO request should be used to determine if there is enough inventory to satisfy the MRO request.

Inventory Update

 - Modified the process to include the Manufacture Date on the ICN Update when the Manufactured Date is required for non shelf life managed items. (Help Ticket #5392).

Receiving

- LPWHN19 - Receiving
 - Corrected a deficiency which caused the user to receive a Javascript error when selecting the Components Button of a Receiving document that was currently in Quality Control (Help Ticket #5428).

Stock Number Inquiry

- LPWHQ46 - Stock Number Inquiry
 - Corrected a deficiency which caused the user to receive a Javascript when exporting the Stock Number Inquiry result grid (Help Ticket #5518).

DD Form 1348

- LPWHR01 - DD Form 1348
 - Corrected a deficiency which caused the user to be unable to print a 1348 when the stock number was less than 4 characters in length (Help Ticket #5636).

Conduct Physical Inventory

- LPWHN57 - Conduct Physical Inventory
 - Corrected a deficiency which caused duplicate serial numbers to be displayed on the inventory sheet and not allowing the user to save the records after they are modified (Help Ticket #5612).

ICN Inventory Inquiry

- LPWHQ47 - ICN Inventory Inquiry
 - Modified the inquiry to include the "Expiration Dt" field in the available columns to be added to the inquiry (Help Ticket #5655).

Outbound DLMS Transactions

- LPWHI03 - SCS Outbound File Generator
 - Corrected a deficiency in the generation of certain 856S DLMS transactions wherein the TCN section was rendered, but there was no TCN included. Found via emails from DLA TS containing invalid XML sent from DPAS.
 - Corrected a deficiency wherein changing the condition code of an SCS controlled item through the QC process did not generate DLMS documents. (continuation of Help Ticket #3952)

Member Profile

- LPWHN25 - Member Profile AUD

- o The process was corrected to parse EAS date field on import correctly. Bug was found during internal testing for this release, and was found to exist in the existing production version.

Unit Issue Reconciliation

- LPWHN69 - Unit Issue Reconciliation
 - o Corrected a deficiency wherein trying to sign a Unit Issue Reconciliation for an outstanding items list without a custodian in the system errors out, sending the user to the error page. Should this circumstance occur, users are now prompted to enter a Custodian before signing. Error was discovered through monitoring of production error logs, not via a help desk ticket.
