Release 2.6.10 for the Defense Property Accountability System (DPAS) Property Accountability (PA) and Warehouse Module (WM) was released on January 30, 2015. This release corrects program deficiencies identified by the user community and the DPAS teams. There is no action required by the user to receive the update.

### **System Change Requests (SCRs):**

The following SCRs are included as part of Release 2.6.10.

### **Maintenance and Utilization (M&U) Module**

#### **Vehicle Type/Group Code Adds**

For Fleet Managers to complete Federal Automated Statistical Tool (FAST) reportable vehicle profiling, Vehicle Characteristics have to be defined.

**Maintenance Asset Master** - Added the identified values for the Vehicle Type and Group Code to Vehicle Characteristics.

### **Warehouse Management (WM) Module**

#### **Supply Control System (SCS) Interface**

**SCS Interface Import** - SCS Interface Import - Process was updated to include modified business rules to take the Retention Quantity into account.

#### **SCS Interface File Generator**

- Process was updated to standardize the data in the 945A/ARJ/AEJ/ARL transaction sets.
- Process was updated to correct the format of the outbound XML transaction by separating the Document Number and suffix using the correct XML schema format.
- Process was updated to add additional management codes for denial scenarios in the outbound denial transactions.
- Process was updated to include updated segment values in the outbound XML. (Remedy #114210, 114215)
- Process was updated to include changes to the Document Identifier Code (DIC) for the outbound 947I when reporting an Owning DoDAAC change.

- Process was updated to display the full Stock Number for Part Number NSNs. (Remedy #114288)
- Corrected a deficiency where the AU0 return to response was setting the format and transaction incorrectly. (Remedy #114289)

- Corrected a deficiency which caused LIN/TAMCNs to disappear after mass update. (Remedy #112645, 114011)

Disposition - Corrected a deficiency where the scroll bars were not displayed when a user disposes of multiple assets. (Remedy #113102)

Inventory Reconciliation - Corrected a deficiency which prevented the user from selecting multiple assets. (Remedy #114420)

Accounting

Real Property - Corrected a deficiency which generated an error when using "Transfer Outside DPAS" in the Disposition process. (Remedy #114481)

Catalog

Stock Number AUD - Corrected a deficiency which caused an error when adding a Stock Number from the FEDLOG. (Remedy #112376)

Reports

Assets on Loan Report - Corrected a deficiency which caused assets to appear under the wrong UIC on this report. (Remedy #113325)

Equipment Utilization (M&U) - Corrected a deficiency which prevented the user from generating this report, also referred to as a Trip Ticket. (Remedy #114417)

Inquiries

Capital Asset Inquiry - Added the description of the Depreciation Code to the Search Criteria Values. (Remedy #114427)

#### Maintenance and Utilization

Dashboard - Corrected a deficiency which displayed "PROCERROR" in the Open Actions list. (Remedy #114094)

Dispatch - Corrected a deficiency which prevented users from finding Dispatch Requests with no asset assigned. (Remedy #113883)

Work Plan ID Browse - Corrected a deficiency which prevented the user from selecting a Work Plan template from other Maintenance Activities. (Remedy #114403, #114428)

#### **Warehouse Management (WM) Module**

##### MyDPAS

Account Information - Corrected a deficiency which displayed duplicate entries on the Training Status tab. (Remedy #113393)

##### Catalog Management

Stock Number AUD - Corrected a deficiency which allowed the user to add a Stock Number with a Calibration, Test, Maintenance, and/or Inspection month interval value of 0.

SKO Catalog AUD - Corrected a deficiency which caused the Grid Options to display incorrectly. (Remedy #113524)

##### Material Management

###### Receiving

- Process was updated to include the Requisition Project Cd field within the Search Criteria and provide the user the ability to add the field to the Search Results Grid.
- Corrected a deficiency which prevented a user from completing a receipt because of a Serial Number validation message.

###### Individual Issue

- Corrected a deficiency which caused the quantity within Individual Issue to double the quantity of items desired. (Remedy #114051)
- Corrected a deficiency which prevented the completion of a Container Pick. (Remedy #114085)
- Corrected a deficiency which caused a problem with Individual Issue and Return processes related to the DW05 form. (Remedy #114200)

###### Warehouse Transfer

- Process was updated to include a data fix for a Pick error. (Remedy #113881)

- Corrected a deficiency which prevented an asset receipt from a Warehouse Transfer. (Remedy #114519)
- Corrected a deficiency which caused an incorrect inventory count during the Warehouse Transfer. (Remedy #114555)

#### Inquiries

Document Inquiry - Corrected a deficiency on the Document Inquiry search to include Unit Issues. (Remedy #113844)

Inventory - Inventory Control Number (ICN) Inventory Inquiry - Process was updated to include the Zones column on the ICN Inventory Inquiry for a Warehouse that is set to use Zones. (Remedy #113561)

#### DLMS Transaction Activity Inquiry

- Process was updated to display the looped data portions of a transaction on the DLMS Transaction Activity Inquiry.
- Corrected a deficiency which caused the Verified and Accepted Quantities and Condition Code to be recorded incorrectly. (Remedy #114164)
