

#### **Participant Questions and Comments:**

**QUESTION**: How do I find out if I need WAWF?

ANSWER: There is no requirement for the use of WAWF for property accountability. It is simply a

tool which can make your job quicker and more accurate.

QUESTION: If for any reason the government has a few hundred items to enter into DPAS that it

already owns, could the government use the WAWF interface into DPAS to transfer the

items in?

**ANSWER**: If you were transferring those assets to another activity or vendor, you could use WAWF

to begin the receiving process. If you simply need to get those assets onto the property

book, entering them directly into DPAS is your best alternative.

**QUESTION**: When would a vendor buy property from the Government?

**ANSWER**: The Government often purchases material and equipment from vendors. This process

usually requires a contract and payment typically is handled via WAWF.

**QUESTION**: Are there any plans to provide DPAS webinars or training that covers Military Equipment

and the MEV process?

**ANSWER**: Not at this time. We will note your request and see if we can schedule one when we

start conducting webinars again in the Fall.

**QUESTION**: How do you track the NSN's for multiple items ordered via contract?

ANSWER: Items entered into WAWF are done so using Contract Line Item Numbers (CLINs) which

can indicate an asset's National Stock Number (NSN). When a transaction comes into DPAS as a new procurement, it always comes in as a single asset transaction. For example, if the vendor entered a CLIN for three widgets, you would see three Pending

"AS" transactions in DPAS.

**QUESTION**: What government representative would initiate in WAWF?

ANSWER: The individual who handles your WAWF transactions now would likely be the individual

who could handle WAWF transfers.

**QUESTION**: Can you touch on 2-in-1 invoices?

**ANSWER**: Invoice 2in1 (Services Only) is covered in FAR 32.905: Payment and Process. Because

DPAS does not accept "AS" transactions without UIIs, and Service contracts do not contain them, this invoice type is not used when interfacing WAWF with DPAS.

**QUESTION**: When is WAWF going to be a standard requirement?

**ANSWER**: WAWF is typically required for vendor invoicing. It is only used as a supplement to

accept assets into DPAS.

**QUESTION**: What government role in WAWF would initiate a transfer? **ANSWER**: To ship an asset in WAWF requires a WAWF Shipper role.

#### **DPAS and WAWF**

**QUESTION**: After receiving an Asset, can you store it or pull up later?

**ANSWER**: Once on the property book, the asset can be referenced by the Doc Number or by Asset
